

1.318 Ac. TRACT Description for deed for Jon Woehrmyer et ux.

Real estate situated in the Village of Minster, Jackson Township, Auglaize County, State of Ohio, and bounded and described as follows:

Being part of 59.261 Ac. tract in the Village of Minster, Section 22, Town 7 South, Range 4 East, and being more particularly described as follows;

Commencing at a monument box marking the northeast corner of the south-east quarter of said section 22;

thence South 00°09'30" East along the east section line a distance of six hundred sixty and five hundredths feet (660.05') to a P-K nail, said point being the TRUE POINT OF BEGINNING;

thence South 89°27'55" West along the south line of a 3.602 acre tract as described in official records volume 254 Page 208 of the Auglaize County Recorders Office, a measured distance of five hundred seventy-four and forty-one hundredths feet (574.41') to an iron pin;

thence South 00°32'05" East a distance of one hundred and zero hundredths feet (100.00') to an iron pin;

thence North 89°27'55" East a distance of five hundred seventy-three and seventy-six hundredths feet (573.76') to a P-K nail;
