Thence, continuing along the south line of said South Park Drive, South $71^{\circ}49'00''$ west, a distance of forty-four and 52/100 (44.52) feet to a 5/8 inch iron bar. Said point being the place of beginning for the herein described parcel-

Thence, continuing along the south line of said South Park Drive, south $71^{\circ}49'00"$ west, a distance of two hundred forty-eight and 29/100 (248.29) feet to a one inch iron bar-

Thence, south $00^{\circ}38'53"$ west, along the west line of said Tract Four, a distance of three hundred ninety-five and 84/100 (395.84) feet to a 5/8 inch iron bar-

Thence, south $87^{\circ}10'19"$ east, along the south line of said Tract Four, a distance of two hundred thirty-five and 17/100 (235.17) feet to a 5/8 inch iron bar-

Thence, north $00^{\circ}38'53"$ east, a distance of four hundred eighty-four and 93/100 (484.93) feet to the place of beginning.

Containing 2.376 acres of land more or less.



VANDERHORST SURVEY DESCRIPTION (TRACT "B")

Being a parcel of land situated in Tract Four of South Park Subdivision in the City of St. Marys and also being situated in St. Marys Township, Auglaize County, Ohio in the southeast quarter of Section 10, Township 6 South, Range 4 East. Being more particlarly described as follows:

Beginning at a one inch iron bar at the northeast corner of said Tract Four-

Thence, north $70^{\circ}27'52"$ east, along the south line of South Park Drive, a distance of sixty-eight and 23/100 (68.23) feet to a 5/8 inch iron bar-

Thence, south 21°52'23" east, along the west line of a 2.526 acre tract of land conveyed to Moran Brothers-Partnership by deed recorded in O.R. 31, page 733, a distance of three hundred seventy-five and 09/100 (375.09) feet to a 5/8 inch iron bar-

Thence, south 53°27'08" west, a distance of two hundred sixty and 46/100 (260.46) feet to a 5/8 inch iron bar at the southeast corner of said Tract Four-

Thence, south $62^{\circ}51'41"$ west, along the south line of said Tract Four, a distance of one hundred thirty-six and 22/100 (136.22) feet to an iron pipe-

Thence, continuing along the south line of said Tract Four, north $87^{\circ}10'19"$ west, a distance of forty and 93/100 (40.93) feet to a 5/8 inch iron bar-

Thence, north $00^{\circ}38'53"$ east, a distance of four hundred eighty-four and 93/100 (484.93) feet to a 5/8 inch iron bar-

Thence, north $71^{\circ}49'00"$ east, along the south line of South Park Drive, a distance of forty-four and 52/100 (44.52) feet to a one inch iron bar-

Thence, continuing along the south line of South Park Drive, north $70^{\circ}46'20''$ east, a distance of one hundred twenty-six and 58/100 (126.58) feet to the place of beginning.

Containing 3.256 acres of land more or less of which 1.438 acres are outside the corporation limits of the City of St. Marys,

Subject to a certain 25 foot easement granted to the City of St. Marys and recorded in Deed Volume 203, page 234, and all other easements and right-of-way of record.
