

Thence with a bearing of N. 00°-19'-22" E. along the East line of the Northeast Quarter of said Section 21, and the centerline of Pepple Road (Township Road #281), for a distance of 311.54 feet to a P.K. Nail/Shiner (set) and the PLACE OF BEGINNING;

Thence with a bearing of N. 89°-40'-38" W. for a distance of 220.00 feet to an iron pin (set), and passing thru an iron pin (set), for reference at 20.00 feet;

Thence with a bearing of N. 00°-19'-22" E. for a distance of 40.00 feet to an iron pin (set);

Thence with a bearing of S. 89°-40′-38" E. for a distance of 220.00 feet to a P.K. Nail/Shiner (set), and passing thru an iron pin (set) for reference at a distance of 200.00 feet;

Thence with a bearing of S. 00°-19'-22" W. along the East line of the Northeast Quarter of said Section 21, and the centerline of Pepple Road (Township Road #281), for a distance of 40.00 feet to a P.K. Nail/Shiner (set) and the PLACE OF BEGINNING.

Thence with a bearing of N. 00°-19'-22" E. for a distance of 40.00 feet to an iron pin (set);

Thence with a bearing of S. 89°-34'-38" E. for a distance of 220.00 feet to a P.K. Nail/Shiner (set), and passing thru an iron pin (set) for reference at a distance of 200.00 feet;

Thence with a bearing of S. 00°-19'-22" W. along the East line of the Northeast Quarter of said Section 21, and the centerline of Pepple Road (Township Road #281), for a distance of 40.00 feet to an Auglaize County Monument Box and the PLACE OF BEGINNING.
