

LEGAL DESCRIPTION

Situate in the Original Plat to the City of Wapakoneta, Auglaize County, Ohio and being a 1.33 foot strip off of the west line of the north half of a vacated alley lying between Lot 57 and 58 of said Original Plat, and more particularly described as follows:

Commencing at a 5/8" re-rod w/cap (found) at the northeast corner of Lot 57 of the Original Plat to the City of Wapakoneta; thence, with an assumed bearing of N 90 degrees 00' 00" W along the south right-of-way line of Main Street and the north line of said Lot 57 and a portion of an alley vacated by Ordinance #43, for a distance of 65.25 feet to a 5/8" re-rod w/cap (set), said re-rod being the **POINT OF BEGINNING** for the strip of land herein described;

thence, S 00 degrees 27' 13" W for a distance of 75.24 feet to a 5/8" re-rod w/cap (set);

thence, S 89 degrees 56' 17" W for a distance of 1.33 feet to a 5/8" re-rod w/cap (found) at the southeast corner of the north half of Lot 58;

thence, N 00 degrees 27' 13" E along the east line of said Lot 58, for a distance of 75.24 feet to a 5/8" re-rod w/cap (found) at the northeast corner of said Lot 58;

thence, S 90 degrees 00' 00" E along a portion of the north side of the aforesaid vacated alley for a distance of 1.33 feet to the **POINT OF BEGINNING**, containing therein 25 square feet or 0.002 acres.
