
# LOCATION SKETCH






### LAUTH SURVEY

#### LAUTH SURVEY DESCRIPTION

Being a parcel of land situated in Noble Township, Auglaize County, Ohio, in the northeast quarter of Section 17, Township 5 South, Range 4 East. Being more particularly described as follows:

Commencing for reference at the cornerstone at the southwest corner of the northeast quarter of said Section 17 -

Thence, east, along the south line of the northeast quarter of said Section 17 and the centerline of Arnold Road, a distance of five hundred five and 13/100 (505.13) feet to a spindle. Said point being the place of beginning for the parcel of land to be conveyed by this instrument -

Thence, continuing, east, along the last described line, a distance of fifty-five and 45/100 (55.45) feet to a spindle -

Thence, north  $02^{\circ}51'51''$  east, a distance of one hundred eighty-five and 11/100 (185.11) feet to a 5/8 inch iron bar -

Thence, north  $06^{\circ}34'48"$  east, a distance of one hundred sixty-six and 11/100 (166.11) feet to a 5/8 inch iron bar -

Thence, north  $89^{\circ}58'02"$  west, a distance of eighty-one and 64/100 (81.64) feet to a 5/8 inch iron bar -

Thence, south 00°20'29" west, a distance of three hundred forty-nine and 95/100 (349.95) feet to the place of beginning.

Containing 0.528 acres of land more or less.

Subject to all easements and right-of-way of record.
