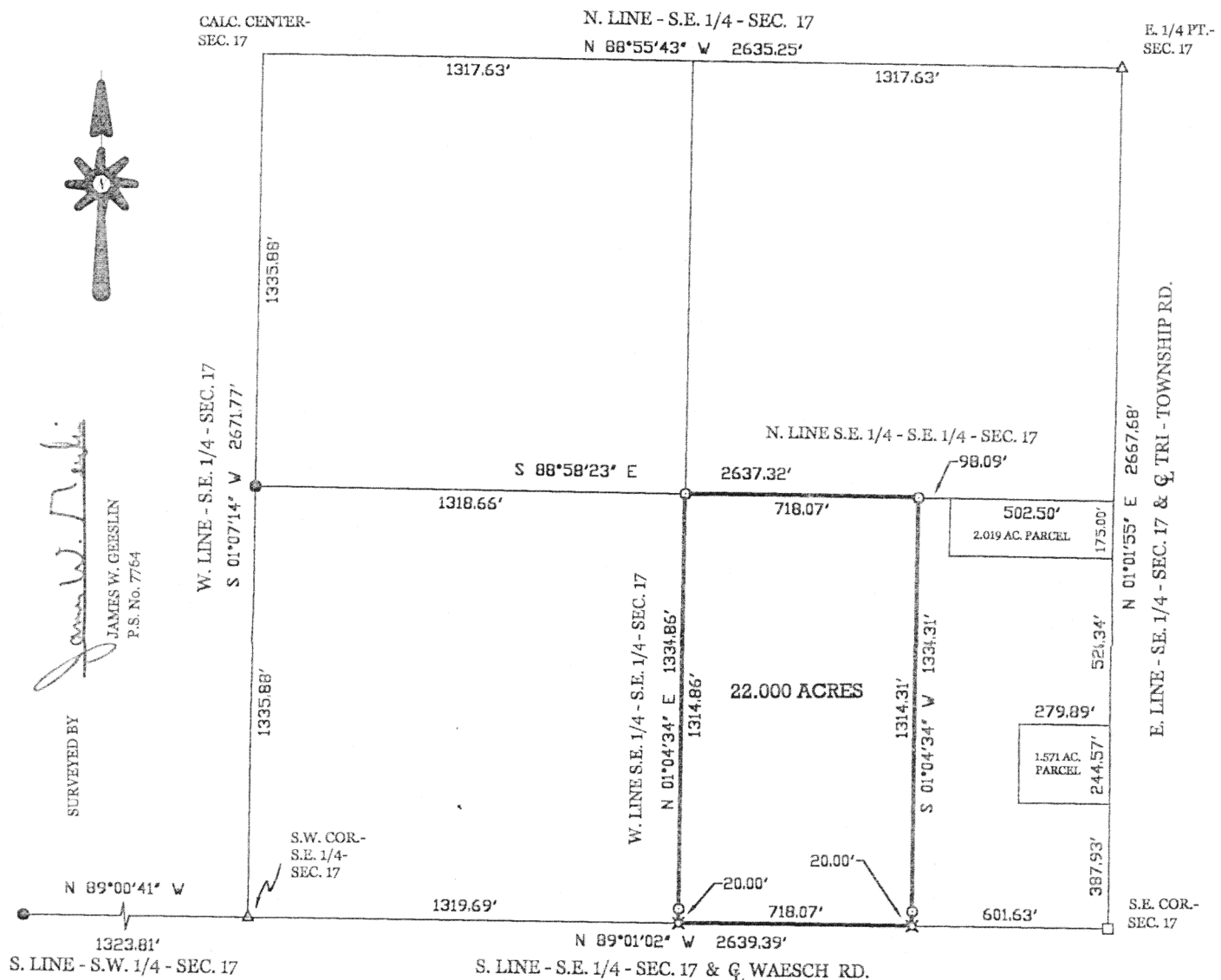


Δ = CORNERSTONE IN AUG. CO. MON. BOX.

( ST. MARYS TOWNSHIP ) , AUGLAIZE COUNTY , OHIO.

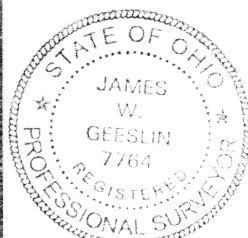

MAKLEY SURVEY DESCRIPTION

Being a parcel of land situated in St. Marys Township, Auglaize County, Ohio, in the southeast quarter of the southeast quarter of Section 17, Township 6 South, Range 4 East. Being more particularly described as follows :

Commencing for reference at an iron bar in a monument box at the southeast corner of said Section 17 -

Thence, north 89°01'02" west, along the south line of the southeast quarter of said Section 17 and the centerline of Waesch Road, a distance of 601.63 feet to a spindle. Said point being the place of beginning for the parcel of land to be conveyed by this instrument -

Thence, continuing, north 89°01'02" west, along the last described line, a distance of 718.07 feet to a spindle -

Thence, north 01°04'34" east, along the west line of the southeast quarter of the southeast quarter of said Section 17, a distance of 1334.86 feet to a 5/8 inch iron bar -

Thence, south 88°58'23" east, along the north line of the southeast quarter of the southeast quarter of said Section 17, a distance of 718.07 feet to a 5/8 inch iron bar -

Thence, south 01°04'34" west, a distance of 1334.31 feet to the place of beginning.

Containing 22.000 acres of land more or less.

Subject to all easements and right-of-way of record.
