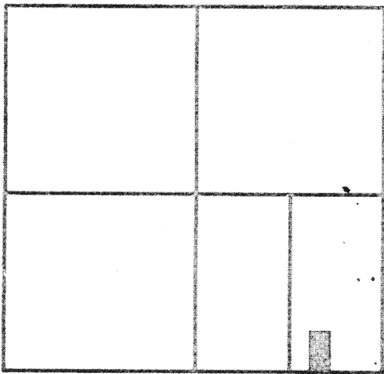


LOCATION SKETCH

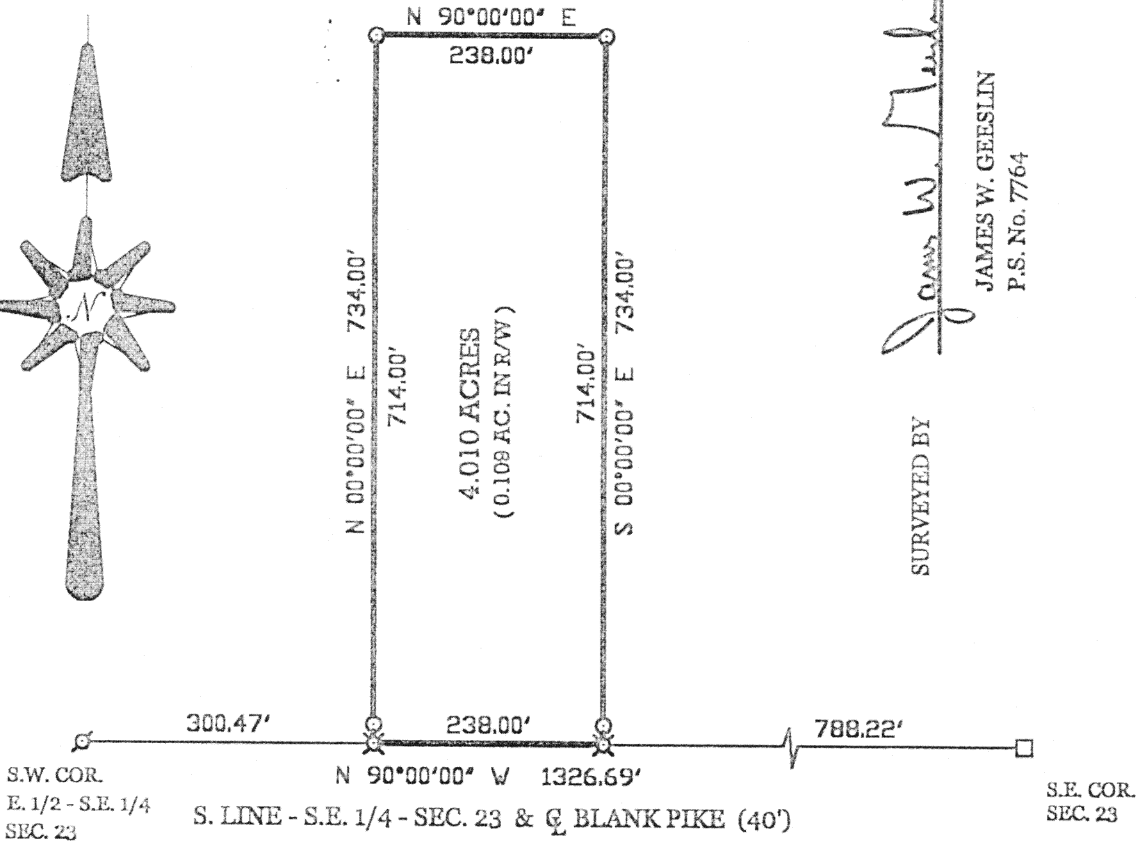
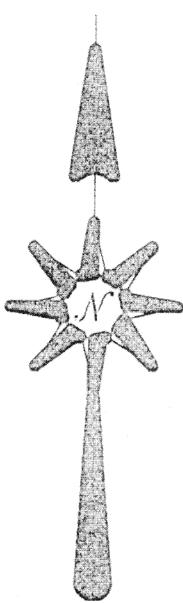

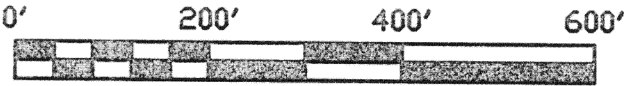

GROSS SURVEY DESCRIPTION

Being a parcel of land situated in Union Township, Auglaize County, Ohio, in the east half of the southeast quarter of Section 23, Township 5 South, Range 7 East. Being more particularly described as follows :

Commencing for reference at an iron bar in a monument box at the southeast corner of said Section 23 -

Thence, west, along the south line of the southeast quarter of said Section 23 and the centerline of Blank Pike, a distance of seven hundred eighty-eight and 22/100 (788.22) feet to a spindle. Said point being the place of beginning for the parcel of land to be conveyed by this instrument -

Thence, continuing, west, along the last described line, a distance of two hundred thirty-eight (238.00) feet to a spindle -

Thence, north, a distance of seven hundred thirty-four (734.00) feet to a 5/8 inch iron bar -

Thence, east, a distance of two hundred thirty-eight (238.00) feet to a 5/8 inch iron bar -

Thence, south, a distance of seven hundred thirty-four (734.00) feet to the place of beginning.

Containing 4.010 acres of land more or less.

Subject to all easements and right-of-way of record.
