




LOCATION PLAN




Duchouquet Township T-4-S, R-6-E, Auglaize County, Ohio.

Thence N.00°59'27"E. along the West line of the Southeast Quarter of Section 35, a distance of 16.00 feet to an iron pin set;

Thence N.89°33'43"W., parallel to the South line of the Southwest Quarter of Section 35, a distance of 431.87 feet to an iron pin set;

Thence N.01°00'01"E. a distance of 633.92 feet to an iron pin set which is the PLACE OF BEGINNING for the tract of land herein described;

Thence continuing N.01°00'01"E. a distance of 282.24 feet to an iron pin set; Thence S.89°25'20"E., along the South line of the P. 

Thence N.00°59'27"E. along the West line of the Southeast Quarter of Section 35, a distance of 16.00 feet to an iron pin set, which is the PLACE OF BEGINNING for the tract of land herein described;

Thence N.89°33'43"W., parallel with the South line of the Southwest Quarter of Section 35, a distance of 431.87 feet to an iron pin set;

Thence N.01°00'01"E. a distance of 633.92 feet to an iron pin set;

Thence S.89°25'20"E. a distance of 1,101.43 feet to a Mag Nail set, passing thru an iron pin set for reference at 1,056.15 feet in the Westerly right-of-way line of County Road 25-A;
