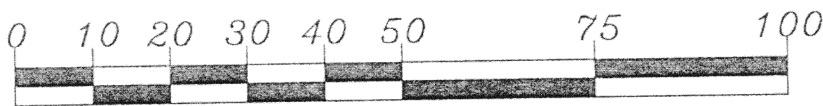
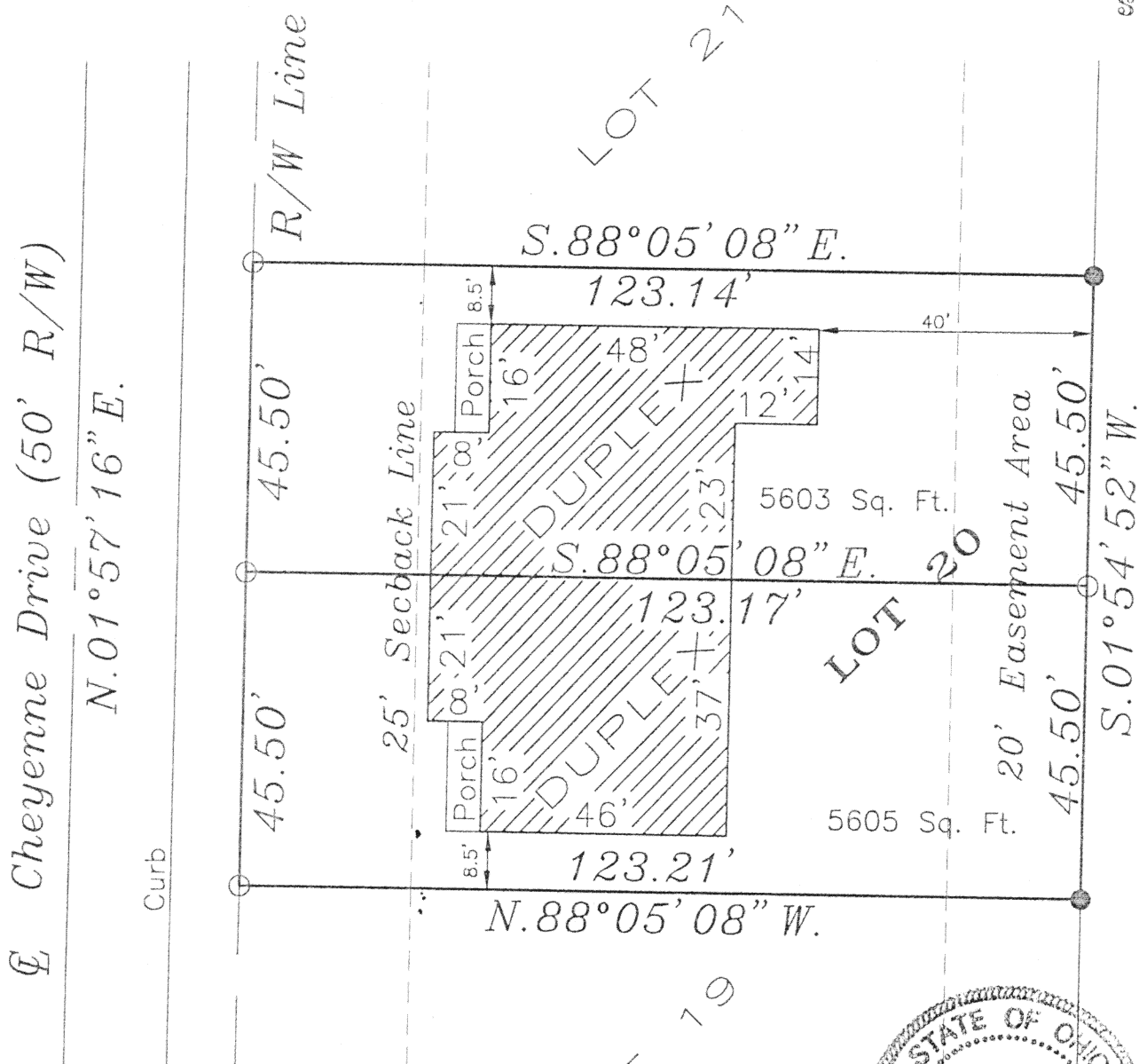
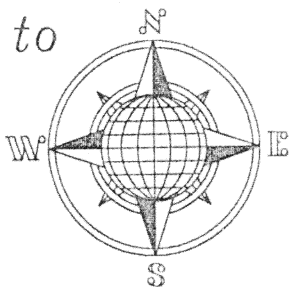


TOM HOYING LOT SURVEY

Being the North and South Part of Lot No. 20 of the Georgetown Estates Plat to the City of Wapakoneta, Ohio.



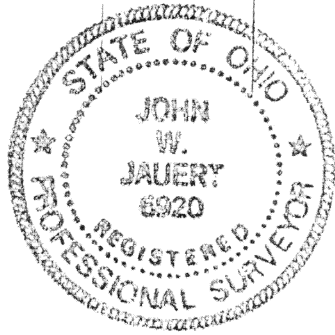

Thence S.88°05'08"E. along the North line of Lot No. 20, a distance of 123.14 feet to an iron pin found;


Thence S.01°54'52"W. along the East line of Lot No. 20, a distance of 45.50 feet to an iron pin set;

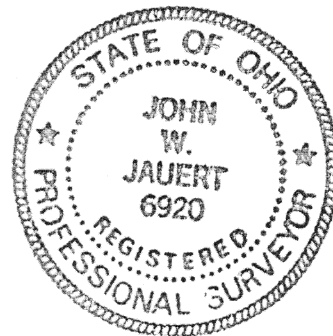
Thence N.88°05'08"W. along the projected common wall line of a duplex residence, a distance of 123.17 feet to an iron pin set;



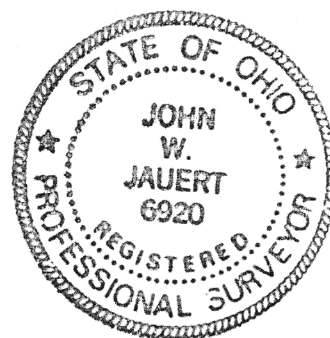
