


Intersection of Boundary Road



SURVEYOR'S DESCRIPTION FOR 4.822 ACRE PARCEL  
SITUATED IN SECTION 34, UNION TOWNSHIP,  
AUGLAIZE COUNTY, OHIO

The following described parcel of land is situated in the Southwest Quarter of Section 34, Union Township, Town-5-South, Range-7-East, Auglaize County, Ohio, and is more particularly described as follows:

Commencing at an Iron Pin (found) at the intersection of the South line of the Southwest Quarter of said Section 34, Union Township, with the centerline of Boundary Road (Township Road #223), and the PLACE OF BEGINNING;

Thence with a bearing of N. 00°-03'-55" E. along the centerline of Boundary Road, (Township Road #223), for a distance of 309.56 feet to a Mag Nail and Shiner (set);

Thence with a bearing of S. 89°-22'-47" E. and parallel with the South line of the Southwest Quarter of said Section 34, Union Township, and the centerline of Federal Route 33, for a distance of 678.55 feet to an Iron Pin (set), and also passing thru an Iron Pin (set) on the Easterly right-of-way line of Boundary Road at a distance of 50.32 feet;

Thence with a bearing of S. 00°-03'-55" W. and parallel with the centerline of Boundary Road, (Township Road #223), for a distance of 309.56 feet to a point, and passing thru an Iron Pin (set) on the Northerly right-of-way line of Federal Route 33 at a distance of 249.56 feet;

Thence with a bearing of N. 89°-22'-47" W. along the South line of the Southwest Quarter of said Section 34, Union Township, and the centerline of Federal Route 33, for a distance of 678.55 feet to an Iron Pin (found) and the PLACE OF BEGINNING.

Containing in all 4.822 Acres of land, of which, 1.342 Acres being previously dedicated for highway purposes. The above described parcel of land is also subject to all other legal easements, reservations, or restrictions, if any, upon said premises.

The Basis of Bearings used for this Survey was determined from the Auglaize County Engineer's Global Positioning Survey. Previous Deed References: Deed Volume OR63, Page 944, Auglaize County Recorder's Office.
