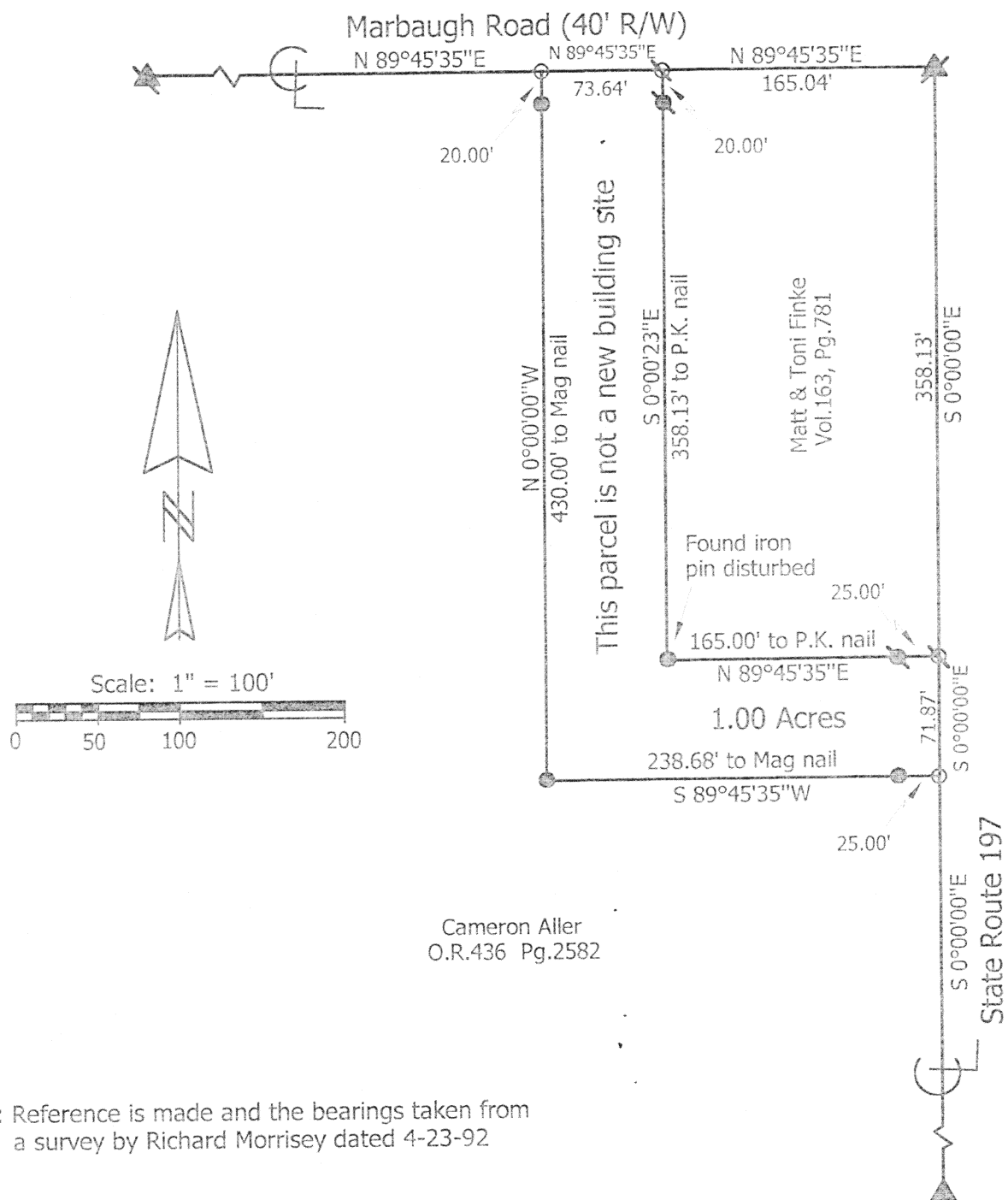

FINKE SURVEY DESCRIPTION

Being a parcel of land situated in Salem Township, Auglaize County, Ohio, and in the southeast quarter of Section 33, Township 4 South, Range 4 East, being more particularly described as follows:

Commencing at a P.K. nail found at the east quarter post of said Section 33;

thence S 00° 00' 00" E, 358.13 feet along the east line of the southeast quarter of said Section 33 and also being the centerline of State Route 197 to a P.K. nail found being the Point of Beginning;

thence continuing S 00° 00' 00" E, 71.87 feet along the last described line to a MAG nail set;

thence S 89° 45' 35" W, 238.68 feet and passing through an iron pin with cap set at 25.00 feet to an iron pin with cap set;

thence N 00° 00' 00" W, 430.00 feet and passing through an iron pin with cap set at 410.00 feet to a MAG nail set;

thence N 89° 45' 35" E, 73.64 feet along the north line of the southeast quarter of said Section 33 and also being the centerline of Marbaugh Road to a P.K. nail found;

thence S 00° 00' 23" E, 358.13 feet and passing through an iron pin found at 20.00 feet to an iron pin with cap set;

thence N 89° 45' 35" E, 165.00 feet and passing through an iron pin found at 140.00 feet to the Point of Beginning, containing 1.00 acres of land more or less, subject to all valid easements and right-of-way.

All bearings were calculated from angles turned in an actual field survey by Kent B. Marbaugh, Registered Surveyor #7421, dated November 5, 2001, on file in the County Engineer's Office.
