

HARDESTY DESCRIPTION 3.760 ACRE

The following described tract of land is part of the Northwest Quarter of Section 16, Town 5 South, Range 7 East, Union Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a Monument Box found at the Northwest corner of the Northwest Quarter of Section 16, Union Township and in the centerline of County Road 180 (Fairmount Road);

Thence S.89°50'32"E. along the centerline of County Road 180 and the North line of the Northwest Quarter of Section 16, a distance of 1,161.99 feet to a Mag Nail set, which is the PLACE OF BEGINNING for the tract of land herein described:

Thence continuing S.89°50'32"E. along the above described line, a distance of 194.04 feet to a Mag Nail set;

Thence S.00°09'28"W. a distance of 232.82 feet to an iron pin set, passing thru an iron pin set for reference at 25.00 feet in the South right-of-way line of County Road 180;

Thence S.89°50'32"E. parallel to the centerline of County Road 180 and the North line of the Northwest Quarter of Section 16, a distance of 158.67 feet to an iron pin set;

Thence S.00°28'58"W. a distance of 286.72 feet to an iron pin set;

Thence S.88°37'00"W. a distance of 435.80 feet to an iron pin set;

Thence N.00°59'54"E. a distance of 169.55 feet to an iron pin set;

Thence N.87°21'38"E. a distance of 71.80 feet to an iron pin set;

Thence N.01°48'50''E. a distance of 358.37 feet to a Mag Nail set, passing thru an iron pin set for reference at 333.37 feet in the South right-of-way line of County Road 180, said Mag Nail was the true PLACE OF BEGINNING.

Containing in all 3.760 Acres of which 0.111 Acre is subject to easement for highway purposes. The above-described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume OR 448, page 1344. Thence S.89°50'32"E. along the centerline of County Road 180 and the North line of the Northwest Quarter of Section 16, a distance of 1,356.03 feet to a Mag Nail set, which is the PLACE OF BEGINNING for the tract of land herein described;

Thence continuing S.89°50'32"E. along the above described line, a distance of 209.60 feet to a Mag Nail set;

Thence S.00°09'28"W. a distance of 232.82 feet to an iron pin set, passing thru an iron pin set for reference at 25.00 feet in the South right-of-way line of County Road 180;


