
## BILL LINK SURVEY

### SURVEYOR'S DESCRIPTION 0.982 ACRE

of the Southeast Quarter of Section 5, Logan Township; thence N.02°01'00"E. along the West line of the Northeast Quarter of Section 5,

a distance of 83.20 feet to a R.R. Spike found; thence S.77°58'00"E. along the centerline of State Route 197, a distance of

241.25 feet to a Mag Nail set;
thence S.07°45'43"W. a distance of 180.78 feet to a point, passing thru an iron
pin set for reference at 30.08 feet in the South right-of-way line of State Route 197;
thence N.80°03'23"W. a distance of 222.12 feet to an iron pin found;

thence N.00°17'30"E. along the West line of the Southeast Quarter of Section 5, a distance of 108.00 feet to the Monument Box at the Northwest Corner of the Southeast Quarter of Section 5, said Monument Box was the true PLACE OF BEGINNING.

Containing in all 0.982 acres of which 0.083 acre has been dedicated for highway purposes: 0.315 Acre located in the Northeast Quarter and 0.667 Acre located restrictions, easements and reservations, if any, of record or in use on said premises. #### BILL LINK DESCRIPTION 1.189 ACRE

Thence S.77°58'00"E. along the centerline of State Route 197 a distance of 241.25 feet to a Mag Nail set, which is the PLACE OF BEGINNING for the tract of land herein described;

Thence continuing S.77°58'00"E. along the centerline of State Route 197, a distance of 275.34 feet to P.K. Nail found;

Thence S.07°45'43"W. a distance of 188.73 feet to an iron pin set, passing thru an iron pin found at 30.08 feet in the South right-of-way line of State Route 197 and passing thru an iron pin found from a previous survey at 170.73 feet;

Thence N.77°58'00"W, parallel to the centerline of State Route 197, a distance of 275.34 feet to an iron pin set;
