## LEGAL DESCRIPTION

Being a part of the easterly portion of the West half of the northeast quarter of Section 3, (including that tract described in Deed Volume 221, Page 83) Town-5-South, Range-5-East, Logan Township, Auglaize County, Ohio and more particularly described as follows:

Commencing at a monument box (found) at the northwest corner of the northeast quarter of said Section 3 and the centerline of Monroe Road; thence, S 89 degrees 59' 26" E along the north line of the northeast quarter of said Section 3 and the centerline of Monroe Road, for a distance of 451.50 feet to a cotton gin spindle (found), said spindle being the POINT OF BEGINNING for the tract herein described;

thence, continuing S 89 degrees 59' 26"E along the aforesaid north line and centerline, for a distance of 551.67 feet to a cotton gin spindle (found);

thence, S 00 degrees 00' 34" W (passing through a 5/8" re-rod w/cap found on the south right-of-way line of Monroe Road at a distance of 20.00 feet) for a total distance of 143.60 feet to a 5/8" re-rod w/cap (found);

thence, S 88 degrees 13' 51" E for a distance of 195.39 feet to a 5/8" re-rod w/cap (found);

thence, N 00 degrees 00' 34" E (passing through a 5/8" re-rod w/cap found on the south right-of-way line of Monroe Road at a distance of 129.60 feet) for a total distance of 149.60 feet to a cotton gin spindle (found) on the north line of the northeast quarter of Section 3 and the centerline of Monroe Road;

thence, S 89 degrees 59' 26" E along the aforesaid north line and centerline, for a distance of 138.01 feet to a cotton gin spindle (found):

thence, S 00 degrees 16' 21" E for a distance of 949.75 feet to a 5/8" re-rod w/cap (set);

thence, N 89 degrees 59' 26" W for a distance of 884.26 feet to a 5/8" re-rod w/cap (found);

thence, N 00 degrees 18' 59" W (passing through a 5/8" re-rod w/cap found at a distance of 929.75 feet) for a total distance of 949.75 feet to the POINT OF BEGINNING, containing therein 18.630 acres, of which 0.316 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Basis of bearings is per Auglaize County GPS of the north line of the northeast quarter of Section 3 at S 89 degrees 59' 26" E. Reference is hereby made to an updated plat of survey prepared for the Gibsons on July 4, 1997.
