Road; thence West (N 90° 00' 00" W), in the centerline of said road, assumed bearing, and the south line of said quarter, nine hundred twenty-two and fifty-three hundredths (922.53) feet to a PK nail found at THE PLACE OF BEGINNING; thence West (N 90° 00' 00" W) in the centerline of said road, one thousand four hundred seven and eighty-two hundredths (1,407.82) feet to a Magnail set; thence North zero degrees twenty minutes seven seconds West (N 0° 20' 07" W) one thousand three hundred thirty-five and ninety-seven hundredths (1,335.97) feet to a 1/2 inch rerod found; thence South eighty-nine degrees fifty-nine minutes fifty seconds East (S 89° 59' 50" E) one thousand twenty and seventeen hundredths (1,020.17) feet to a 1/2 inch rerod found; thence North zero degrees twelve minutes eighteen seconds East (N 0° 12' 18" E) one thousand three hundred twenty-two and ninety-nine hundredths (1,322.99) feet to an iron pipe found; thence North eighty-nine degrees fifty-nine minutes thirty-five seconds East (N 89° 59' 35" E) one thousand three hundred twenty-one and thirty-four hundredths (1,321.34) feet to an iron pipe found; thence South zero degrees ten minutes twenty-three seconds West (S 0° 10' 23" W) two thousand two hundred seventy-eight and six hundredths (2,278.06) feet to an iron pipe found; thence West (N 90° 00' 00" W) six hundred sixty-six and eight hundredths (666.08) feet to an iron pipe found; thence South zero degrees ten minutes fifty seconds West (S 0° 10' 50" W) seventy-four and ten hundredths (74.10) feet to an iron pipe found; thence West (N 90° 00' 00" W) two hundred fifty-six and forty-five hundredths (256.45) feet to an iron pipe found; thence South zero degrees ten minutes fifty seconds West (S 0° 10' 50" W) three hundred six and ninety hundredths (306.90) feet to the place of beginning containing one hundred four and one hundred sixty-three thousandths (104.163) acres, more or less, subject to legal highways and all easements and restrictions of record.


