

Commencing at the monument box found at the northeast corner of said quarter in the centerline of I. O. O. F. 65° 35' 14" W) two hundred seventy and forty-five hundredths (270.45) feet to a mine spike found; thence South sixty degrees thirty-one minutes twenty-nine seconds West (S 60° 31' 29" W) one hundred eighty-five and twenty-eight hundredths (185.28) feet to a mine spike found; thence North zero degrees one minute twenty-two seconds East (N 0° 01' 22" E) nine hundred seventy-five and fourteen hundredths (975.14) feet to an iron pipe found; thence North eighty-eight degrees two minutes forty-five seconds East (N 88° 02' 45" E) four hundred thirteen and sixty hundredths (413.60) feet to an iron pipe found; thence North zero degrees twenty-seven minutes zero seconds East (N 0° 27' 00" E) two hundred eighty-five and seventy-one hundredths (285.71) feet to a 1/2 inch rerod found; thence West (N 90° 00' 00" W) two hundred eight and seventy-one hundredths (208.71) feet to a 1/2 inch rerod found; thence North zero degrees twenty-seven minutes zero seconds East (N 0° 27' 00" E) two hundred nineteen and fifty hundredths (219.50) feet to the place of beginning containing eighty-two and eight hundred seventy-four thousandths (82.874) acres, more or less, subject to legal highways and all easements and restrictions of record.

All re-rods set, as called for above, are thirty (30) inches long, are set flush or below the surface, and are topped with a red plastic Permamark® cap stamped "LS 5772". This description and accompanying plat represents a boundary survey completed under my supervision on January 11, 2001 and all markers called for above are in place.
