Thence, continuing, North 00°48'30" East, along the last described line, a distance of 140.05 feet to a 5/8 inch iron bar -

Thence, South 89°35'02" West, a distance of 66.00 feet to a 5/8 inch iron bar -

Thence, South 00°48'30" West, a distance of 139.94 feet to a point -

Thence, North 89°40'37" East, a distance of 66.00 feet to the place of beginning.
