

## BEERS SURVEY DESCRIPTION

Being a parcel of land situated in Goshen Township, Auglaize County, Ohio, and part of the southeast quarter of Section 6, Township 6 South, Range 8 East, being more particularly described as follows:

Commencing at a Monument Box at the east quarter post of said Section 6;

thence S 00° 50′ 57″ W, 348.00 feet along the east line of the southeast quarter of said Section 6 and also being the centerline of Waynesfield Road to a railroad spike found being the Point of Beginning;

thence continuing S 00° 50' 57" W, 331.43 feet along the last described line to a P.K. nail found;

thence N 89° 32' 19" W, 232.43 feet to an iron pin found;

thence S 00° 50' 57" W, 210.00 feet to an iron pin found;

thence S 89° 32' 19" E, 232.43 feet to a P.K. nail found;

thence S 00° 50′ 57″ W, 210.00 feet along the east line of the southeast quarter of said Section 6 and also being the centerline of Waynesfield Road to a P.K. nail found;

thence N 89° 32' 19" W, 232.43 feet to an iron pin found;

thence S 00° 50' 57" W, 225.00 feet to a P.K. nail found;

thence N 89° 32' 19" W, 467.33 feet along the south line of the northeast quarter of the southeast quarter of said Section 6 and also being the centerline of Swartz Road to a P.K. nail found;

thence N 00° 49' 26" E, 225.00 feet to an iron pin found;

thence N 89° 32' 19" W, 624.00 feet to an iron pin found;

thence N 00° 49' 26" E, 1098.42 feet along the west line of the northeast quarter of the southeast quarter of said Section 6 to an iron pin set;

thence S 89° 34′ 55″ E, 1024.35 feet along the north line of the southeast quarter of said Section 6 to an iron pin found;

thence S 00° 50' 57" W, 343.47 feet to an iron pin found;

thence S 88° 43' 03" E, 300.00 feet to the Point of Beginning, containing 32.316 acres of land more or less, subject to all valid easements and right-of-way.

All bearings were calculated from angles turned in an actual field survey by Kent B. Marbaugh, Registered Surveyor #7421, dated March 30, 2002, on file in the County Engineer's Office.
