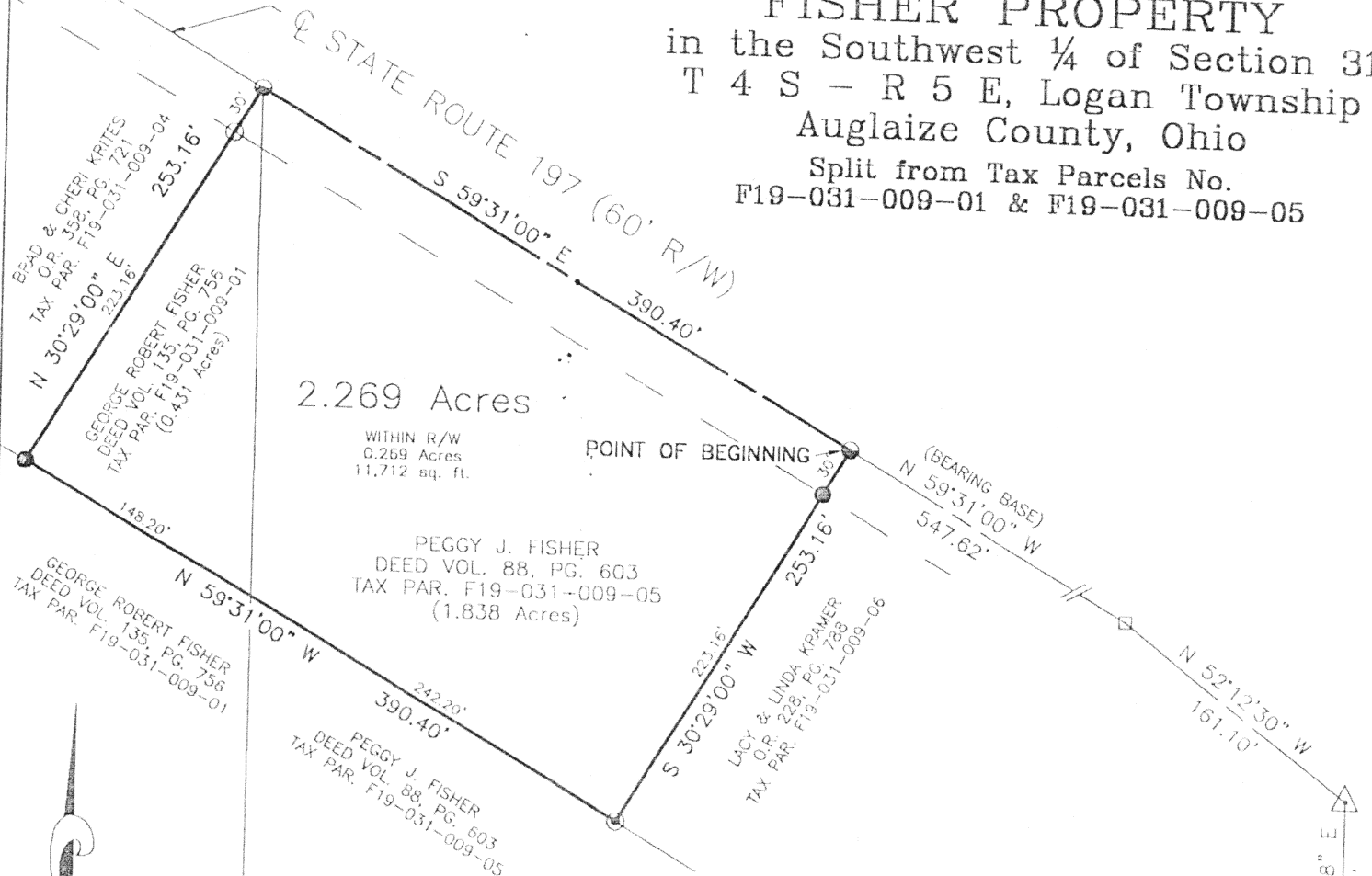
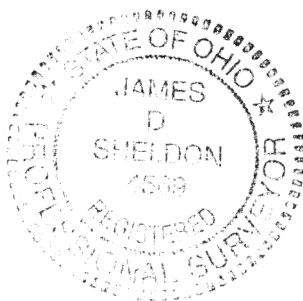


Plat of a Survey

 F19-031-009-01 & F19-031-009-05



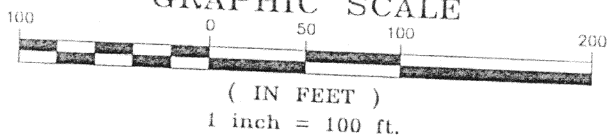

REVISED DESCRIPTION

2.269 ACRES

Being a parcel of land situated in the Southwest Quarter of Section 31, Township 4 South, Range 5 East, Logan Township, Auglaize County, Ohio, and being a Part of Tax Parcel F19-031-009-05 granted to Peggy J. Fisher by Warranty Deed recorded in Deed Book 88, Page 603 and a part of Tax Parcel F19-031-009-01 granted to George Robert Fisher by Warranty Deed recorded in Deed Book 135, Page 756, of the Auglaize County, Ohio, deed records and more particularly described as follows:

Commencing for reference at a 1-1/2" uncapped iron pipe found marking the southeast corner of the Southwest Quarter of said Section 31 -

Thence North 00°-08'-18" East for a distance of 117.66 feet to a railroad spike found on the centerline of State Route 197 -

Thence on and along said centerline with the following two (2) courses:

- 1) North 52°-12'-30" West for a distance of 161.10 feet to a chiseled "X" on the lid of a monument box found -
- 2) North 59°-31'-00" West (bearing base) for a distance of 547.62 feet to a PK nail found marking the **PRINCIPAL POINT OF BEGINNING** for the parcel to be described by this instrument -

Thence South 30°-29'-00" West for a distance of 253.16 feet to a 5/8-inch iron pin with "S&A, Lima, OH" cap found, passing at 30.00 feet a 5/8-inch iron pin with "S&A Lima, Ohio" cap found -

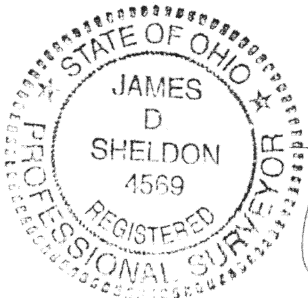
Thence North 59°-31'-00" West for a distance of 390.40 feet to a 5/8-inch iron pin with "S&A Lima, Ohio" cap found -

Thence North 30°-29'-00" East for a distance of 253.16 feet to a PK nail found on the centerline of State Route 197, passing at 223.16 feet a 5/8-inch iron pin with illegible cap found -

Thence South 59°-31'-00" East on and along said centerline for a distance of 390.40 feet to the **place of beginning**.

The foregoing description is based on a field survey performed September 27, 2000, under the supervision of Ohio Registered Professional Surveyor James D. Sheldon (#4569). The tract as described **contains in all 2.269 acres of land** (of which 1.838 acres are in Tax Parcel F19-031-009-05 and 0.431 acres are in Tax Parcel F19-031-009-004), with 0.269 acres being within the road right of way, subject, however, to all legal easements and rights of way.
