

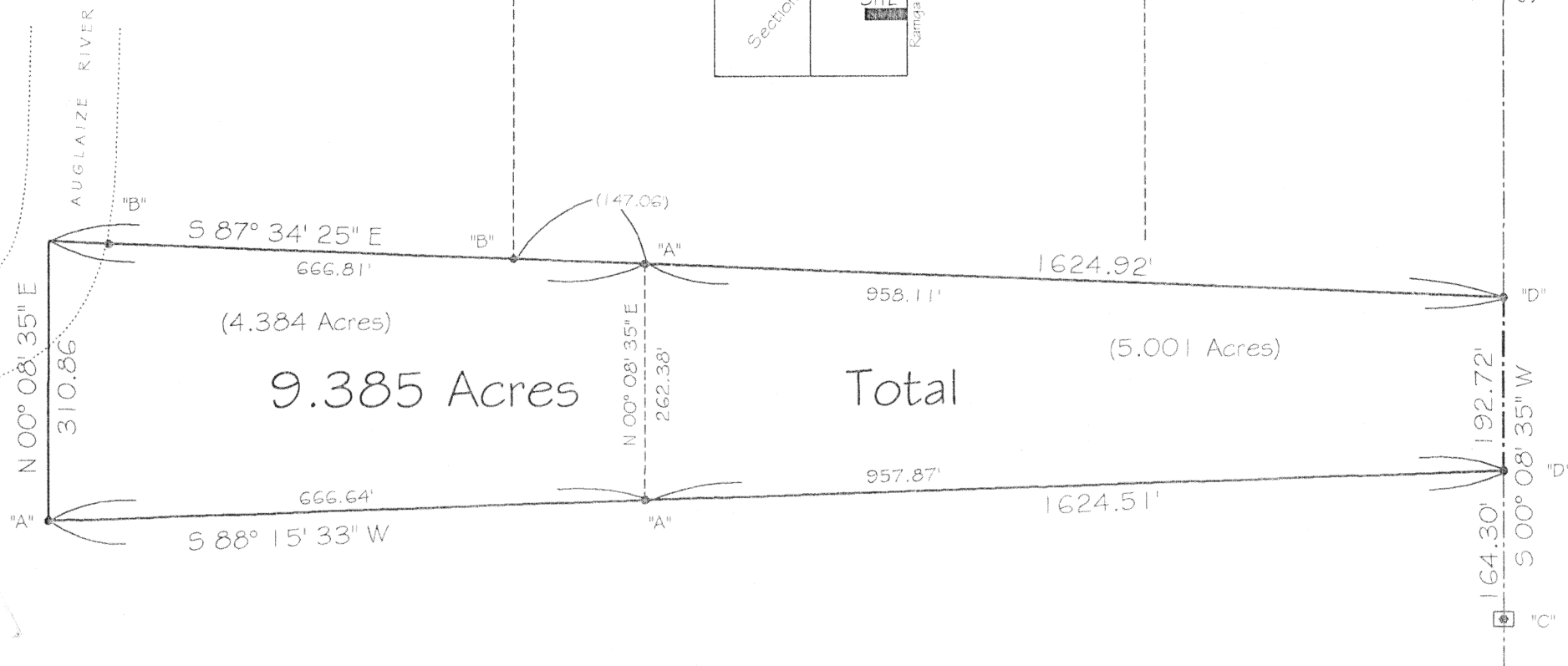
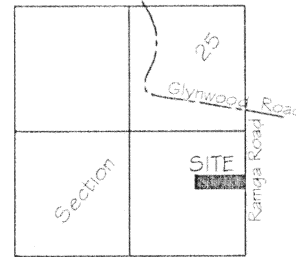
# Koenig Survey of 9.385 Acres

Being 9.385 Acres located in the southeast quarter of Section 25, Town 5 South, Range 5 East, Moulton Township, Auglaize County, Ohio and being further described as follows:

Commencing at a monument box located at the northeast corner of the southeast quarter of Section 25;

Thence South  $00^{\circ} 08' 35''$  West along the east line of Section 25 and centerline of Ramga road, a distance of 969.25 feet to a PK Spike set and PLACE OF BEGINNING for the parcel herein described;

Thence continuing South  $00^{\circ} 08' 35''$  West along said centerline and section line, a distance of 192.72 feet to a PK Spike set;

Thence South  $88^{\circ} 15' 33''$  West, a distance of 1624.51 feet to an iron bar set;

Thence North  $00^{\circ} 08' 35''$  East, a distance of 310.86 feet to a point in the centerline of the Auglaize River;

Thence South  $87^{\circ} 34' 25''$  East, a distance of 1624.92 feet to the PLACE OF BEGINNING, passing through an iron bar found at 94.77 feet & at 519.75 feet.

Thence South  $88^{\circ} 15' 33''$  West, a distance of 957.87 feet to an iron bar set;

Thence North  $00^{\circ} 08' 35''$  East, a distance of 262.38 feet to an iron bar set;

Thence South  $87^{\circ} 34' 25''$  East, a distance of 958.11 feet to the **PLACE OF BEGINNING**.
