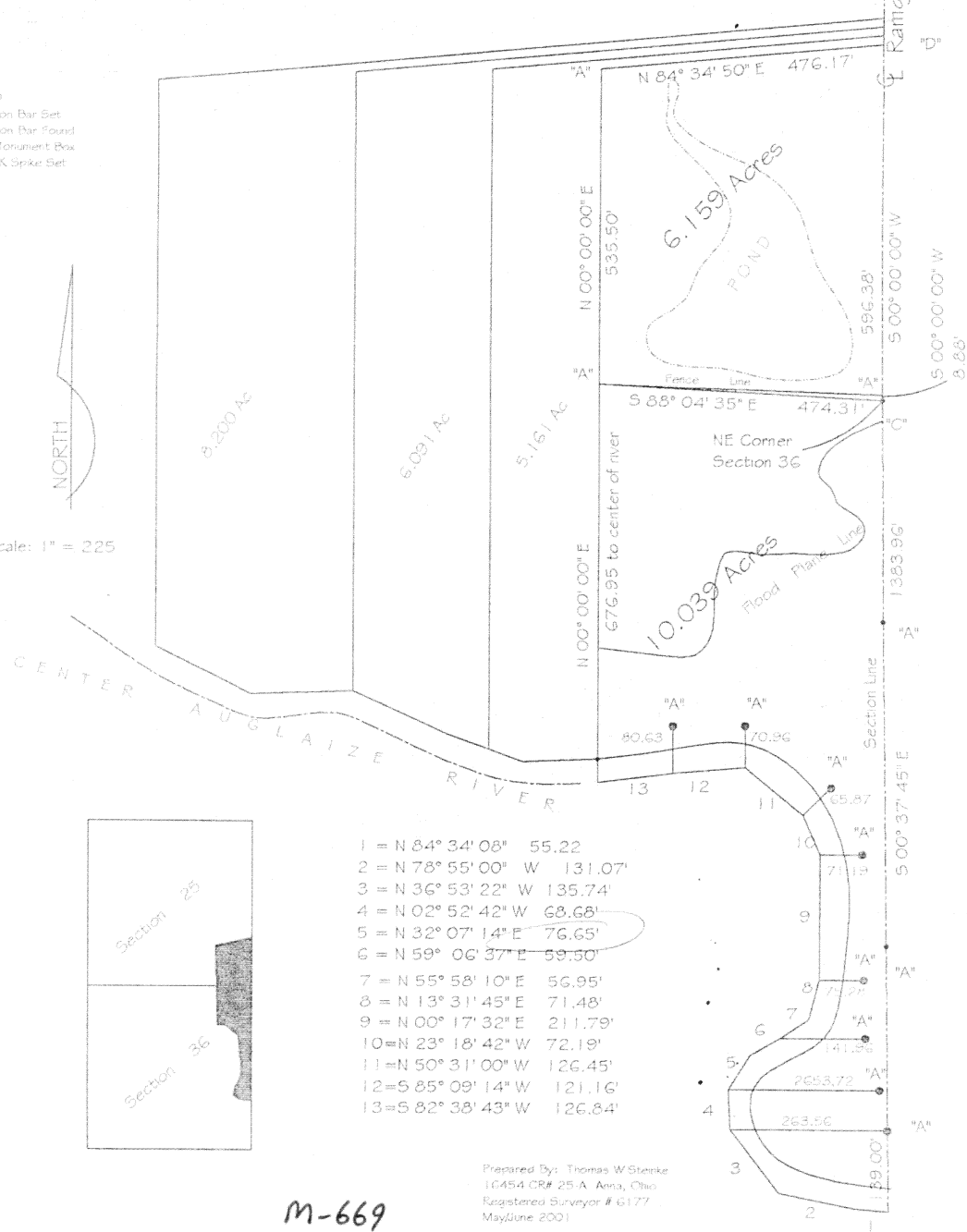

Description of 10.062 Acres for Koenig

Being 10.062 Acres located in the southeast quarter of Section 25 and the northeast quarter of Section 36, Town 5 South, Range 5 East, Moulton Township, Auglaize County, Ohio and being further described as follows:

Commencing at a monument box located at the northeast corner of Section 36 and the PLACE OF BEGINNING for the parcel herein described;

Thence South $00^{\circ} 37' 45''$ East along the east line of Section 36 and centerline of Ramga Road, a distance of 1383.96 feet to a point in the center of Auglaize River, passing through an iron bar set at 1244.96 feet;

The next 13 courses follow the approximate center of Auglaize River:

Thence North $88^{\circ} 04' 35''$ West, a distance of 474.31 feet to an iron bar set in the east line of an existing 5.161 Acre tract;

Thence North $00^{\circ} 00' 00''$ East, a distance of 535.50 feet to an iron bar set;

Thence North $84^{\circ} 34' 50''$ E, a distance of 476.17 feet to a PK Spike set in the east line of Section 25 and centerline of Ramga Road;
