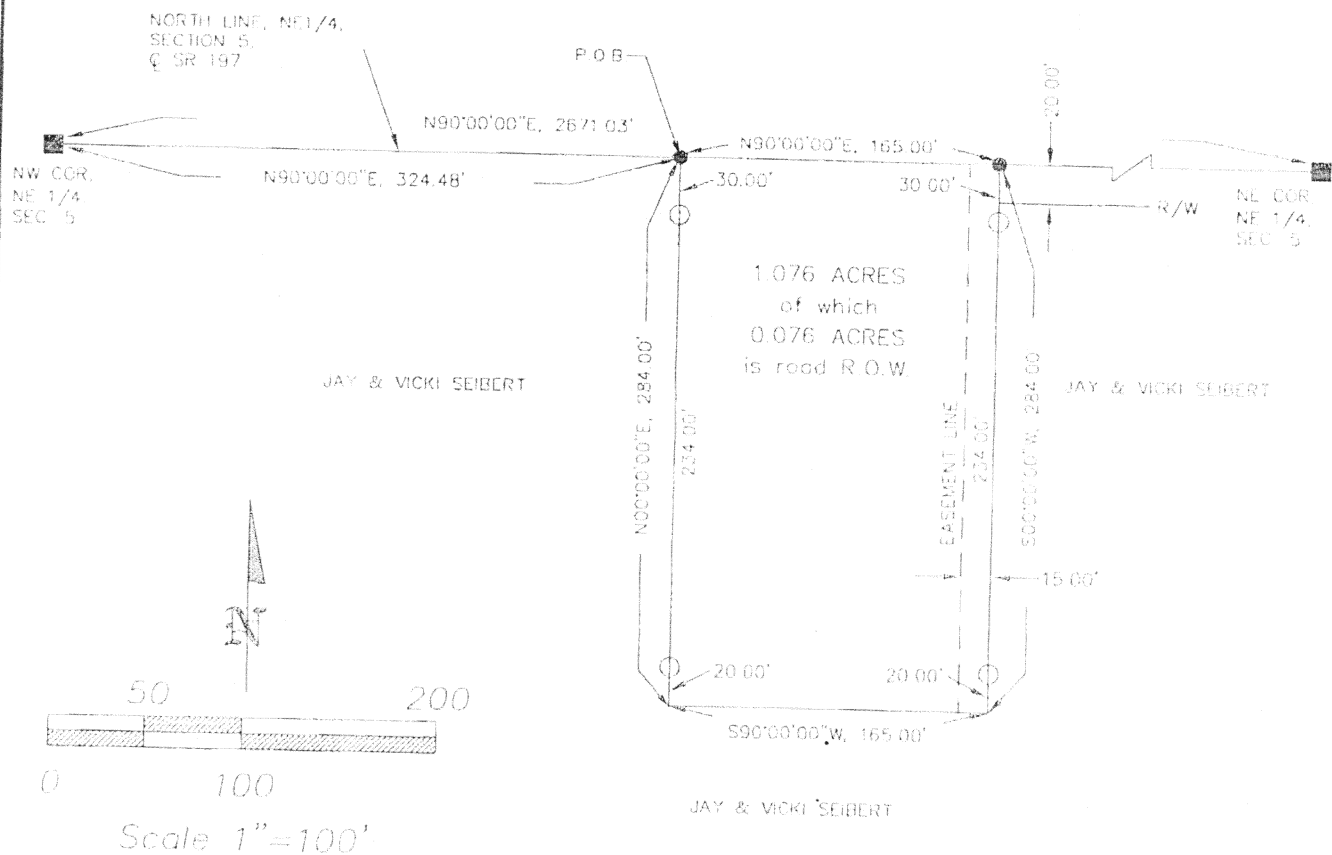

DESCRIPTION

Being a part of the parcel owned by Jay and Vicki Seibert located in the NE 1/4 of Section 5, T5S, R4E, Salem Township, Auglaize County, Ohio. More particularly described as follows:

Commencing, for reference, at the monument box at the NW corner of the NE 1/4 of Section 5; thence N 90°-00'-00" E (assumed bearing) on the North line of the NE 1/4 (centerline of State Route 197), 324.48' to a MAG nail set at the POINT OF BEGINNING; thence following courses:

- 1) Continue, N 90°-00'-00" E on the centerline of State Route 197, 165.00' to a set MAG nail;
- 2) S 00°-00'-00" W, 284.00' to a point, passing set #5 Rebars at 30.00' and 264.00';
- 3) S 90°-00'-00" W, 165.00' to a point;
- 4) N 00°-00'-00" E, 284.00' to the POINT OF BEGINNING, passing set #5 Rebars at 20.00' and 254.00'.

The above described parcel of land contains 1.076 acres, more or less, of which 0.076 acres is occupied by road right-of-way. This parcel is subject to all legal highways and easements of record.

The basis of bearings for this description is based on the assumption that the North line of the NE 1/4 (centerline of State Route 197) is N 90°-00'-00" E. This legal description and the accompanying plat represent an actual boundary survey conducted under the direct supervision of Brad J. Core, P.S. #8004 on January 6, 2001.

(Easement for ingress and egress)

Being a part of the parcel owned by Jay and Vicki Seibert located in the NE 1/4 of Section 5, T59, R4E, Salem Township, Auglaize County, Ohio. More particularly described as follows:

Commencing, for reference, at the monument box at the NW corner of the NE 1/4 of Section 5; thence N 90°-00'-00" E (assumed bearing) on the North line of the NE 1/4 (centerline of State Route 197), 489.48' to a MAG nail set at the POINT OF BEGINNING; thence following courses:

- 1) S 00°-00'-00" W, 284.00' to a point, passing set #5 Rebars at 30.00' and 264.00';
- 2) S 90°-00'-00" W, 15.00' to a point;
- 3) N 00°-00'-00" E, 284.00' to a point on the North line of the NE 1/4 (centerline of State Route 197);
- 4) N 90°-00'-00" E on said centerline, 15.00' to the POINT OF BEGINNING.

The above described easement contains 0.098 acres, more or less.

The basis of bearings for this description is based on the assumption that the North line of the NE 1/4 (centerline of State Route 197) is N 90°-00'-00" E.
