

LEGAL DESCRIPTION

scale:

Being a part of the northeast quarter of Section 35, Town-6-South, Range-4-East, St. Marys Township, Auglaize County, Ohio as evidenced by Deed Volume 264, Page 121 and more particularly described as follows:

Commencing for reference at a monument box (found) at the northeast corner of the northeast quarter of Section 35 and the centerline intersection of Plattner Pike and Southland Road; thence, N 89 degrees 04' 57" W along the north line of the northeast quarter of said Section 35 and the legal centerline of Southland Road for a distance of 1697. 16 feet to a 5/8" re-rod w/cap (set), said re-rod being the **POINT OF BEGINNING** of the tract herein described;

thence, \$ 03 degrees 28' 23" W (passing the centerline of pavement of Southland Road at a distance of 17.02 feet, and passing through a 5/8" re-rod w/cap set at the southerly right-of-way line of Southland Road {as occupied} at a distance of 47.05 feet) for a total distance of 446.41 feet to a 5/8" re-rod w/cap (set);

thence, N 88 degrees 33' 30" W for a distance of 190.58 feet to a 5/8" re-rod w/cap (set);

thence, N 02 degrees 03' 10" E (passing through a 5/8" re-rod w/cap set on the southerly right-of-way line of Southland Road {as occupied} at a distance of 397.30 feet, and passing the centerline of pavement of Southland Road at a distance of 414.30 feet) for a total distance of 444.31 feet to a 5/8" re-rod w/cap (set) on the north line of the northeast quarter of Section 35;

thence, S 89 degrees 04' 57" E along the aforesaid north line, for a distance of 201.67 feet to the **POINT OF BEGINNING**, containing therein 2.004 acres, of which 0.217 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Prepared by James M.
