## LEGAL DESCRIPTION

Being a part of the northeast quarter of Section 19, Town-5-South, Range-8-East, Wayne Township, Auglaize County, Ohio and more specifically a part of Lot 128 to the Village of Waynesfield and more specifically described as follows:

Commencing at a "mag" nail (set) at the northwest corner of said Lot 128, said nail also being on the south right-of-way line of Wapakoneta Street (State Route 67); thence, S 89 degrees 03' 35" E along the north line of Lot 128 and the south right-of-way line of Wapakoneta Street, for a distance of 25.43 feet to a "mag" nail (set), said nail being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing along the north line of said Lot 128 and the south right-of-way line of Wapakoneta Street, S 89 degrees 03' 35" E for a distance of 40.57 feet to a "mag" nail (set) at the northeast corner of Lot 128;

thence, S 01 degree 28' 11" W along the east line of said Lot 128, for a distance of 132.00 feet to a 5/8" re-rod w/cap (set) at the southeast corner of said Lot 128;

thence, N 89 degrees 03' 35" W along the south line of said Lot 128, for a distance of 55.39 feet to a 5/8" re-rod w/cap (set) on the easterly right-of-way line of the former Indiana, Columbus and Eastern Traction Company road bed;

thence, N 18 degrees 52' 03" W along the aforesaid easterly line for a distance of 30.53 feet to a 5/8" re-rod w/cap (set) on the west line of Lot 128;

thence, N 01 degree 28' 11" E for a distance of 2.73 feet to a 5/8" re-rod w/cap (set);

thence, S 89 degrees 29' 45" E for a distance of 26.97 feet to a 5/8" re-rod w/cap (set);

thence, N 00 degrees 35' 24" E for a distance of 100.34 feet to the **POINT OF BEGINNING**, containing therein 5,928 square feet. Prepared by James M. ## LEGAL DESCRIPTION

Commencing at a "mag" nail (set) at the northeast corner of said Lot 128, said nail also being on the south right-of-way line of Wapakoneta Street (State Route 67); thence, N 89 degrees 03' 35" W along the north line of Lot 128 and the south right-of-way line of Wapakoneta Street, for a distance of 40.57 feet to a "mag" nail (set), said nail being the **POINT OF BEGINNING** for the tract herein described;

thence, S 00 degrees 35' 24" W for a distance of 100.34 feet to a 5/8" re-rod w/cap (set);

thence, N 89 degrees29' 45" W for a distance of 26.97 feet to a 5/8" re-rod w/cap (set) on the west line of Lot 128;

thence, N 01 degree 28' 11" E along the west line of said Lot 128, for a distance of 100.54 feet to a "mag" nail (set) at the northwest corner of Lot 128 and the south right-of-way line of Wapakoneta Street;

thence, S 89 degrees 03' 35" E along the north line of said Lot 128 and the aforesaid south right-of-way line, for a distance of 25.43 feet to the **POINT OF BEGINNING**, containing therein 2,632 square feet.
