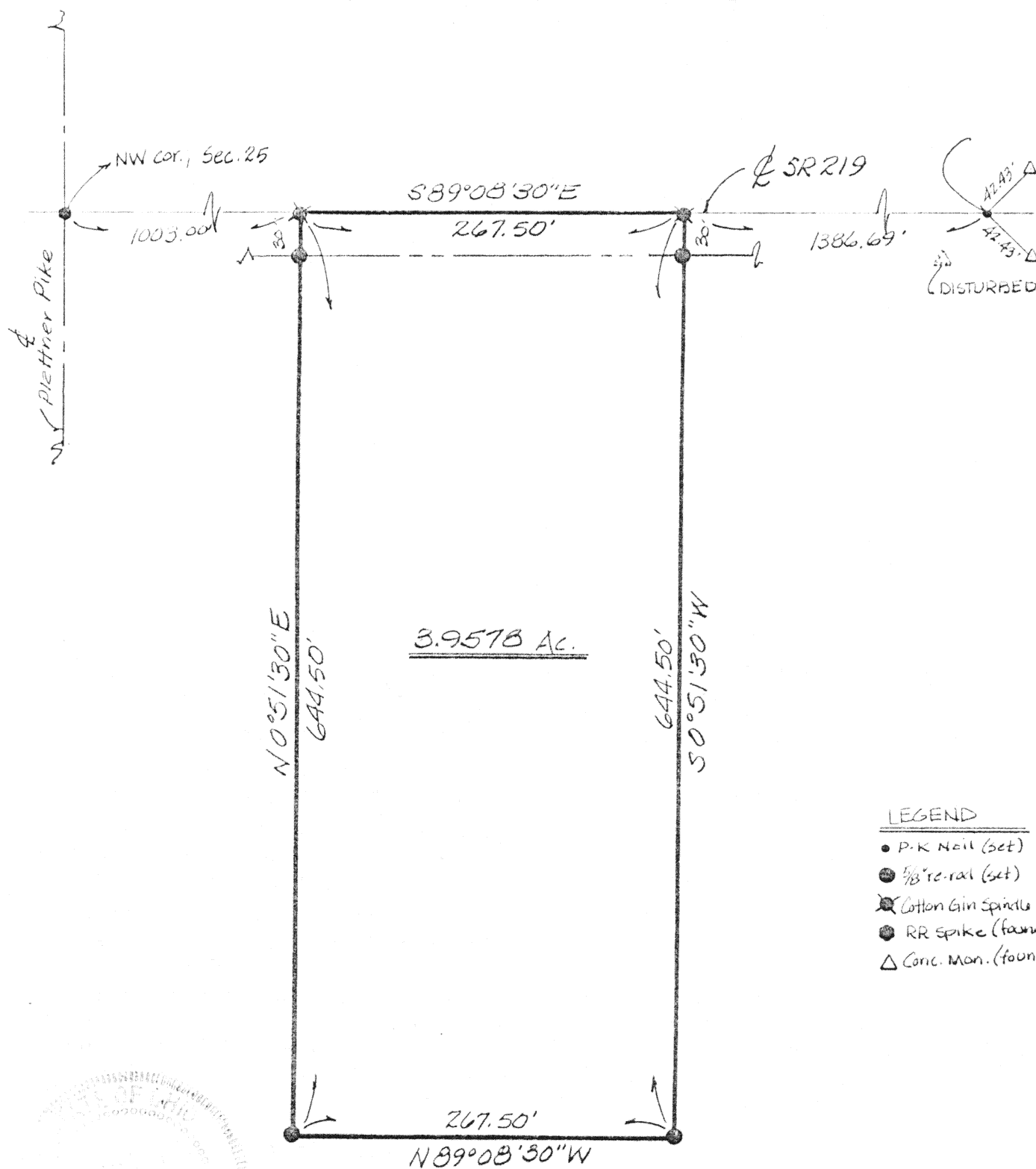

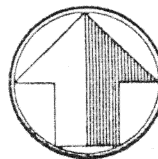

DESCRIPTION

Being a part of the northwest quarter of Section 25, T-6-S, R-4-E, St. Marys Township, Auglaize County, Ohio and being more particularly described as follows:

Commencing at a railroad spike (found) marking the location of the northwest corner of Section 25 and the intersection of the centerline of State Route 219 and Plattner Pike; thence S $89^{\circ}08'30''$ E along the north line of Section 25 and the centerline of State Route 219 for a distance of 1,003.00 feet to a cotton gin spindle (set) and the PLACE OF BEGINNING;

thence continuing S $89^{\circ}08'30''$ E along the north line of Section 25 and the centerline of State Route 219 for a distance of 267.50 feet to a cotton gin spindle (set);

thence S $00^{\circ}51'30''$ W (passing through a $5/8''$ re-rod w/cap set at a distance of 30.00 feet) for a total distance of 644.50 feet to a $5/8''$ re-rod w/cap (set);

thence N $89^{\circ}08'30''$ W for a distance of 267.50 feet to a $5/8''$ re-rod w/cap (set);

thence N $00^{\circ}51'30''$ E (passing through a $5/8''$ re-rod w/cap set at a distance of 614.50 feet) for a total distance of 644.50 feet to the PLACE OF BEGINNING, containing therein 3.9578 acres more or less, of which 0.184 acres is reserved for highway purposes.
