


LEGAL DESCRIPTION

scale:

Being a part of the northeast quarter of Section 26, T-6-S, R-4-E, St. Marys Township, Auglaize County, Ohio as evidenced by Deed Volume 226, Page 368 and more particularly described as follows:

Commencing at a p-k nail (found) marking the location of the North quarter corner of Section 26, and the centerline of State Route 219; thence, S 88 degrees 57' 26" E along the North line of the northeast quarter of Section 26 and the centerline of SR 219, for a distance of 863.00 feet to a cotton gin spindle (set), said spindle being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing along the aforesaid North line and centerline of SR 219, S 88 degrees 57' 26" E, for a distance of 215.00 feet to a cotton gin spindle (set);

thence, S 01 degree 02' 34" W (passing through a 5/8" re-rod w/cap set for reference on the southerly right-of-way line of SR 219 at a distance of 30.00 feet), for a total distance of 515.00 feet to a 5/8" re-rod w/cap (set);

thence, N 88 degrees 57' 26" W for a distance of 215.00 feet to a 5/8" re-rod w/cap (set);

thence, N 01 degree 02' 34" E (passing through a 5/8" re-rod w/cap set for reference on the southerly right-of-way line of SR 219 at a distance of 485.00 feet) for a total distance of 515.00 feet to the **POINT OF BEGINNING** containing therein 2.541 acres, of which 0.148 acres is road right-of-way.
