



## DESCRIPTION

scale:

Being the southeast part of Lot 7 and a triangular piece of land out of the southeast part of the remainder of Lot 7 of the subdivision of part of Out Lot 30 to the City of Wapakoneta, Auglaize County, Ohio and more particularly described as follows:

Commencing at a 3/4" iron pipe found at the southwest corner of Lot 7 of said subdivision of part of Out Lot 30 (said point also being on the northerly right-of-way line of Bellefontaine Street); thence S 58 degrees 00' 00" E, along the southerly line of the aforesaid Lot 7 and the northerly right-of-way line of said Bellefontaine Street, for a distance of 64.89 feet to a 5/8" re-rod w/cap (set), said point also being the **PLACE OF BEGINNING**, for the parcel herein described;

thence, N 14 degrees 25' 48" E, for a distance of 20.00 feet, to the easterly line of the aforesaid Lot 7, and a 5/8" re-rod w/cap (set);

thence, N 01 degree 56' 04" E, along the easterly line of the aforesaid Lot 7, for a distance of 91.58 feet to a 5/8" re-rod w/cap (found) at the southwest corner of Lot 9 of the subdivision of a part of Out Lot 30;

thence, N 88 degrees 59' 26" E, along the south line of said Lot 9, for a distance of 61.00 feet to a 5/8" re-rod w/cap (found) at the southeast corner of said Lot 9;

thence, S 16 degrees 01' 17" W, along the westerly line of the South part of Lot 10 of the subdivision of a part of Out Lot 30, for a distance of 136.84 feet to a gin spindle (set) at the southwesterly corner of the aforesaid Lot 10 and the northerly right-of-way line of Bellefontaine Street;

thence, N 58 degrees 00' 00" W, along the northerly right-of-way line of said Bellefontaine Street, passing through a chiseled "X" set in concrete at a distance of 31.91 feet at the southerly terminus of the easterly line of Lot 7), for a total distance of 36.91 feet to the **PLACE OF BEGINNING**, containing therein 5,606 square feet.
