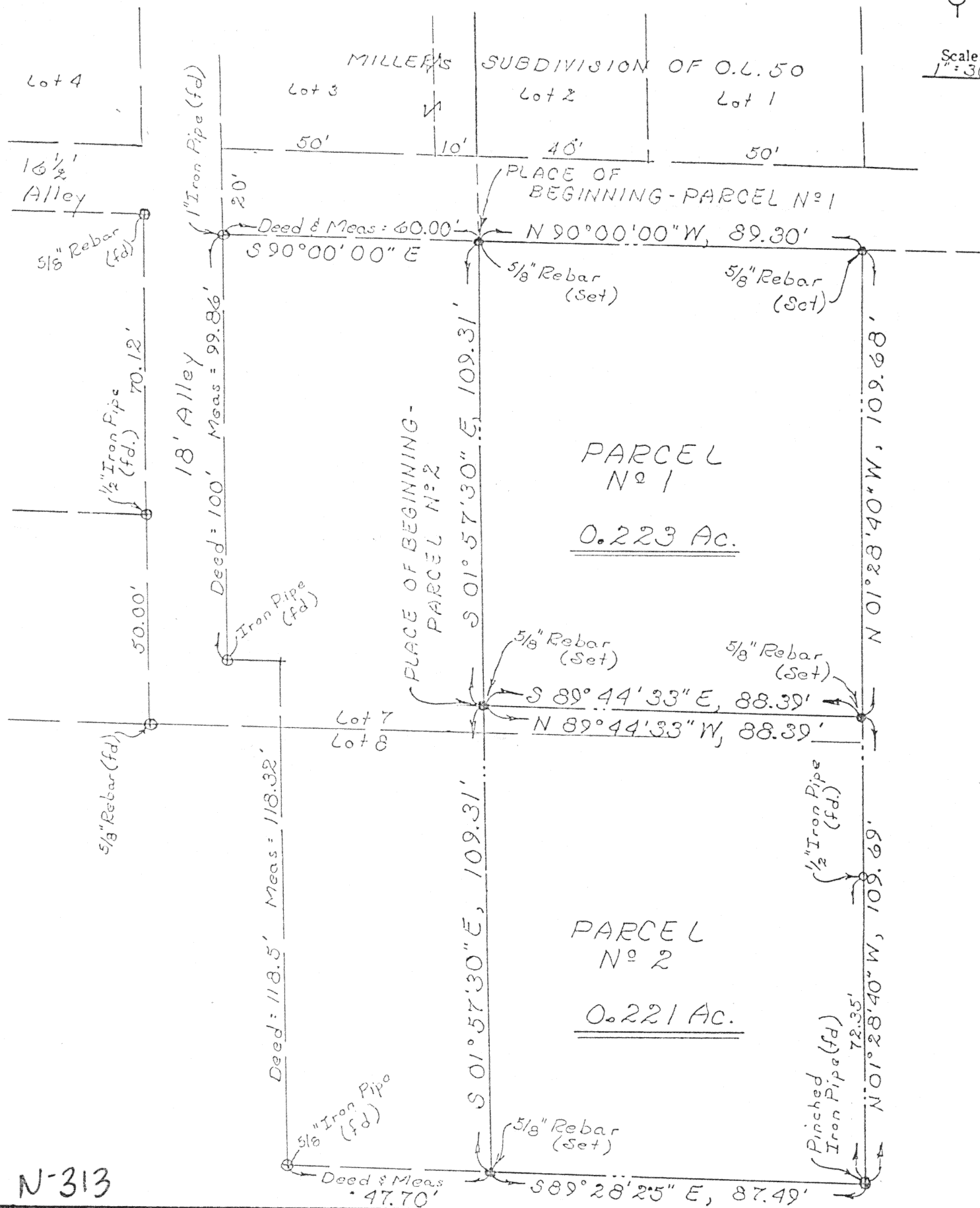


SURVEY OF PART OF LOTS N^o 7 & 8 IN MILLER'S SUBDIVISION OF OUTLOT 50

PARCEL NO. 1

Being a part of Lot No. 7 in Miller's Subdivision of Outlot No. 50 in the City of Wapakoneta, Auglaize County, Ohio and more particularly described as follows:

Commencing at one (1) inch iron pipe found twenty (20) feet south of the southwest corner of Lot No. 3 in said Miller's Subdivision; thence S 90°00'00" E with a line parallel to the south right-of-way line of Benton Street, 60.00 feet to a 5/8 inch rebar set and the PLACE OF BEGINNING; thence S 01°57'30" E, 109.31 feet to a 5/8 inch rebar set; thence S 89°44'33" E, 88.39 feet to a 5/8 inch rebar set; thence N 01°28'40" W, 109.68 feet to a 5/8 inch rebar set; thence N 90°00'00" W, 89.30 feet to the PLACE OF BEGINNING containing 9,723.141 square feet or 0.223 acre more or less and subject to all legal easements of record.

Commencing at one (1) inch iron pipe found twenty (20) feet south of the southwest corner of Lot No. 3 in said Miller's Subdivision; thence S 90°00'00" E with a line parallel to the south right-of-way line of Benton Street, 60.00 feet to a 5/8 inch rebar set; thence S 01°57'30" E, 109.31 feet to a 5/8 inch rebar set and the PLACE OF BEGINNING; thence continuing S 01°57'30" E, 109.31 feet to a 5/8 inch rebar set; thence S 89°28'25" E, 87.49 feet to a pinched iron pipe found; thence N 01°28'40" W (passing through a one-half (1/2) inch iron pipe found at 72.35 feet), 109.69 feet to a 5/8 inch rebar set; thence N 89°44'33" W, 88.39 feet to the PLACE OF BEGINNING containing 9,623.054 square feet or 0.221 acre more or less and subject to all legal easements of record.
