




WEST PEARL STREET (66')

Commencing at a 3/4" "pinch" pipe (found) at the northwest corner of the aforesaid parcel evidenced by Deed Volume 230, Page 306, said point being on the west line of Lot 337, 87.00 feet north of the southwest corner of said Lot 337; thence, with an assumed bearing of S 00 degrees 00' 00" W along the west line of said Lot 337 and the east right-of-way line of Court Street, for a distance of 40.20 feet to a 5/8" re-rod w/cap (set), said re-rod being the POINT OF BEGINNING for the tract herein described;

thence, S 89 degrees 55' 09" E (passing through a 5/8" re-rod set for reference at a distance of 98.57 feet) for a total distance of 100.09 feet to the east line of Lot 338;

thence, S 00 degrees 10' 56" W along the east line of said Lot 338, for a distance of 46.48 feet to a 3/4" "pinch" pipe (found) at the southeast corner of said Lot 338;
