


EASEMENT

LEGAL DESCRIPTION EASEMENT AREA

Being a part of the northwest quarter of Section 33, T-5-S, R-6-E, City of Wapakoneta, Township of Duchouquet, Auglaize County, Ohio and more particularly described as follows:

Commencing at a monument box (found) at the northeast corner of the northwest quarter of said Section 33 and the centerline of Middle Pike; thence, with the North line of the northwest quarter of said Section 33 and the centerline of Middle Pike, N 89 degrees 07' 43" W, for a distance of 656.86 feet to the northerly prolongation of the easterly right-of-way line of Eastown Drive; thence, S 01 degree 52' 23" W along said prolonged easterly right-of-way line for a distance of 25.00 feet to the intersection of the said easterly right-of-way line of Eastown Drive with the southerly right-of-way line of Middle Street, said intersection being the **POINT OF BEGINNING** for the easement herein described;

thence, S 89 degrees 07' 43" E along the southerly right-of-way line of said Middle Street for a distance of 25.00 feet to a point;

thence, S 01 degree 52' 23" W, parallel with the easterly right-of-way line of Eastown Drive, for a distance of 25.00 feet to a point;

thence, N 89 degrees 07' 43" W, parallel with the southerly right-of-way line of Middle Pike, for a distance of 25.00 feet, to the easterly right-of-way line of Eastown Drive;

thence, N 01 degree 52' 23" E, along the aforesaid easterly right-of-way line, for a distance of 25.00 feet to the **POINT OF BEGINNING**, containing therein 0.014 acres. Prepared by James M.
