
PART OF THE SE 1/4

## LEGAL DESCRIPTION

scale:

Being a part of the Southeast quarter of Section 34, T-5-S, R-6-E, Duchouquet Township, Auglaize County, Ohio as evidenced by Deed Volume 182, Page 128, and more particularly described as follows:

Commencing at the South quarter corner of said Section 34 and the centerline of U.S. Route 33; thence with an assumed bearing of N 90 degrees 00' 00" E, along the centerline of said U.S. Route 33, for a distance of 1,487.12 feet to a P-K Nail (found) and the PLACE OF BEGINNING;

thence N 00 degrees 00' 00" E, (passing through a 1/2" re-rod found on the northerly right-of-way line of said U.S. 33 at a distance of 30.00 feet) for a total distance of 271.73 feet to a 5/8" re-rod w/cap (set);

thence N 89 degrees 32' 00" E, for a distance of 401.40 feet to a 5/8" re-rod w/cap (set);

thence S 00 degrees 00' 00" W, (passing through a 5/8" re-rod w/cap set on the northerly right-of-way line of said U.S. 33 at a distance of 245.00 feet) for a total distance of 275.00 feet to a Cotton Gin Spindle (set);

thence S 90 degrees 00' 00" W, along said centerline, for a distance of 401.39 feet to the **PLACE OF BEGINNING**, containing therein, 2.518 acres, of which 0.276 acres is road right-of-way.
