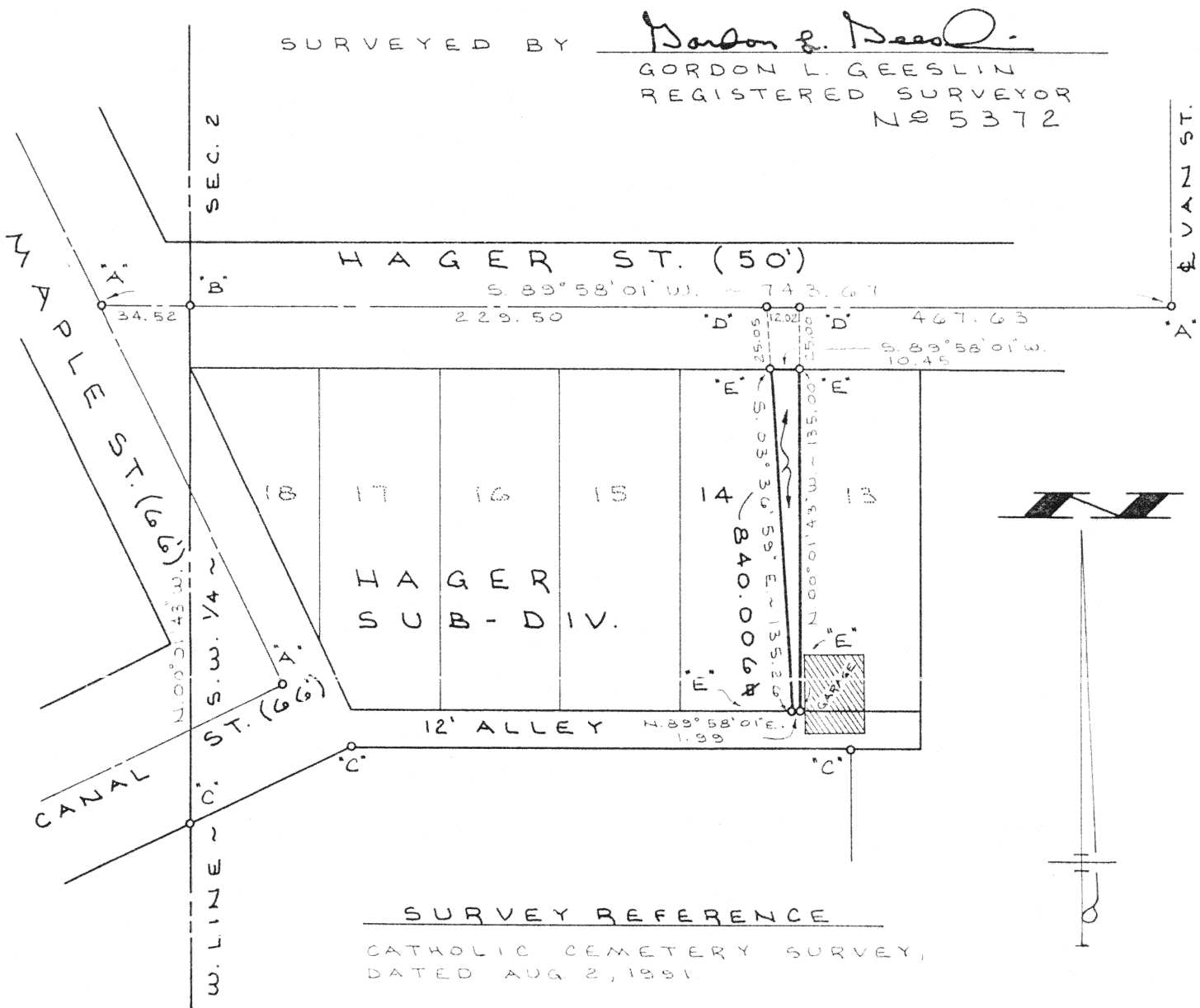


LEGEND

Sheaks Survey Description

Being a part of Lot 14 of the Oliver F. Hager Subdivision of the northwest part of Out Lot Number 118, as recorded in Plat Book 2, Page 88; in the City of St. Marys, Auglaize County, Ohio. Being more particularly described as follows:

Beginning at a 5/8 inch iron bar at the northeast corner of said Lot 14-

Thence, south 89°58'01" west, along the north line of said Lot 14, a distance of ten and 45/100 (10.45) feet to a 5/8 inch iron bar-

Thence, south 03°36'59" east, a distance of one hundred thirty-five and 26/100 (135.26) feet to a 5/8 inch iron bar. Said point being in the south line of said Lot 14-

Thence, north 89°58'01" east, a distance of one and 99/100 (1.99) feet to a 5/8 inch iron bar at the southeast corner of said Lot 14-

Thence, north 00°01'43" west, a distance of one hundred thirty-five (135.00) feet to the place of beginning.

Containing 840.006 square feet of land more or less.
