



LEGAL DESCRIPTION

Being the easterly part of Lot 12 of the Auglaize Pearl Wedge Subdivision of Fraction 5, Section 31, T-5-S, R-6-E, Duchouquet Township, City of Wapakoneta, Auglaize County, Ohio and more particularly described as follows:

Commencing at a p-k nail (set) at the northwest corner of the aforesaid Lot 12; thence, N 63 degrees 50' 06" E along the northerly line of said Lot 12, and the southerly right-of-way line of West Auglaize Street, for a distance of 53.37 feet to a 5/8" re-rod w/cap (set), said re-rod being the **POINT OF BEGINNING** of beginning for the parcel herein described;

thence, continuing along the aforesaid northerly line of Lot 12 and the southerly right-of-way line of West Auglaize Street, for a distance of 46.36 feet to a 1" iron pipe (found) at the northeast corner of Lot 12;

thence, S 21 degrees 01' 38" E for a distance of 81.05 feet to a 1" iron pipe (found) at the southeast corner of Lot 12;

thence, N 89 degrees 44' 42" W along the southerly line of Lot 12 and the northerly line of West Pearl Street, for a distance of 50.29 feet to a 5/8" re-rod w/cap (set);

thence, N 20 degrees 21' 32" W for a distance of 58.65 feet to the **POINT OF BEGINNING**, containing therein 3,251 square feet. Being the western part of Lot 12 of the Auglaize Pearl Wedge Subdivision of Fraction 5, Section 31, T-5-S, R-6-E, Duchouquet Township, City of Wapakoneta, Auglaize County, Ohio and more particularly described as follows:

Commencing at a 1" iron pipe found at the western corner of Lot 13 and the intersection of the southerly right-of-way line of West Auglaize Street and the northerly right-of-way line of West Pearl Street; thence, N 63 degrees 50' 06" E along the northerly line of said Lot 13, and the southerly right-of-way line of West Auglaize Street, for a distance of 70.00 feet to a p-k nail (set) at the northwest corner of Lot 12, said p-k nail being the **POINT OF BEGINNING** of beginning for the parcel herein described;


thence, continuing along the aforesaid northerly line of Lot 12 and the southerly right-of-way line of West Auglaize Street N 63 degrees 50' 06" E, for a distance of 53.37 feet to a 5/8" re-rod w/cap (set);

thence, S 20 degrees 21' 32" E for a distance of 58.65 feet to a 5/8" re-rod w/cap (set);

thence, N 89 degrees 44' 42" W along the southerly line of Lot 12 and the northerly right-of-way line of West Pearl Street, for a distance of 61.13 to a p-k nail (set) at the southwest corner of said Lot 12;

thence, N 12 degrees 57' 18" W along the west line of Lot 12, for a distance of 31.99 feet to the **POINT OF BEGINNING**, containing therein 2,508 square feet.
