

## LEGAL DESCRIPTION

## MINSTER LOCAL SCHOOL DISTRICT

BEING A PARCEL OF LAND SITUATE IN THE NORTHEAST QUARTER OF SECTION 27, TOWN 7 SOUTH, RANGE 7 EAST, JACKSON TOWNSHIP, VILLAGE OF MINSTER, AUGLAIZE COUNTY, OHIO AND BEING PART OF OUTLOTS ONE, TWO, THREE, AND FOUR OF THE SUBDIVISION RECORDED IN PLAT BOOK 1, PAGE 69, OF THE PLAT RECORDS OF AUGLAIZE COUNTY, OHIO, AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Commencing for reference at a point at the southeast corner of the northeast quarter of Section 27, said point being on the centerline of Main Street also known as State Route 66 and on the north line of Seventh Street in the said Village;

thence, South 89°-53'-57" West, 194.61 feet, along the north line of said Seventh Street to an iron pin found at the southwest corner of a tract of land as described in Deed Volume 204, Page 614, and being the principal place of beginning;

thence, South 89°-53'-57" West, 876.87 feet, along the north line of said Seventh Street to an iron pin with cap set at the southeast corner of a tract of land owned by the Village of Minster as recorded in Deed Volume 213, Page 298;

thence, North 00°-21'-00" East, 660.00 feet, along the east line of said Village of Minster tract and parallel with the centerline of Main Street to an iron pin with cap set at a corner of said tract:

thence, North 89°-53'-57" East, 325.00 feet, to an iron pin with cap set at a corner of a tract of land owned by the Village of Minster as described in Deed Volume 219, Page 868;

thence, North 00°-21'-00" East, 439.51 feet, along the east line of said Village of Minster tract and parallel with the centerline of Main Street to an iron pin with cap set, also being on the south line of Parkview Acres Subdivision, Phase No. 1;

thence, North 89°-51'-33" East, 746.48 feet, along the south line of said subdivision to a P.K. nail set on the centerline of said Main Street, also being the East section line of said Section 27, passing for reference an iron pin found on the west right-of-way line of said Main Street at 646.48 feet:

thence, South 00°-21'-00" West, 963.65 feet, along the centerline of said Main Street and section line to a P.K. nail set at the northeast corner of a tract of land as described in Deed Volume 204, Page 614;

thence, South 89°-53'-57" West, 194.61 feet, to an iron pin with cap set at the northwest corner of a tract of land as described in Deed Volume 204, Page 614, passing for reference a concrete monument found at 50.00 feet and a concrete monument found at 70.00 feet with each on the west right-of-way line of said Main Street;

thence, South 00°-21'-00" West, 136.35 feet, along the west line of said Schnelle tract to the principal place of beginning.

Containing 23.087 acres, more or less, of which 2.102 acres lies within the road right-of-way and being subject to all legal highways and easements of record.
