




LOCATION PLAN

## SURVEYOR'S DESCRIPTION

The following described tract of land is part of the Southeast Quarter of Section 14, Town 5 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a R.R. Spike found at the Southeast corner of the Southeast Quarter of Section 14 and in the centerline of State Route 67, a distance of 1,315.73 feet to a P.K. Nail found;

Thence N.00°31'26"E. a distance of 182.00 feet to a point in the centerline of an open ditch which is the PLACE OF BEGINNING for the tract of land herein described; Thence continuing N.00°31'26"E. a distance of 148.61 feet to an iron pin set,

passing thru an iron pin set for reference at 25.00 feet; Thence N.89°53'30"E. a distance of 528.27 feet to an iron pin set;

Thence S.00°40'26"W. a distance of 176.01 feet to an iron pin set; Thence S.89°23'26"W., parallel to the centerline of State Route 67, a distance

of 290.40 feet to a point; Thence S.00°40'26"W. a distance of 150.00 feet to a point in the centerline of of State Route 67;

thence N.89°23'26"E. along the centerline of State Route 67 and the South line of the Southeast Quarter of Section 14, a distance of 65.09 feet to a P.K. Nail found; Thence N.29°49'34"W. along the centerline of an open ditch, a distance

153.87 feet to a point;
Thence N.63°14'34"W along the centerline of an open ditch, a distance of 105.60 feet to a point, which was the true PLACE OV BNEGINNING.
