

PARCEL NO. 1 DESCRIPTION 30.125 ACRE

The following described tract of land is part of the Northwest Quarter of Section 15, Town 5 South, Range 8 East, Wayne Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a Monument Box found at the Northwest corner of the Northwest Quarter of Section 15, Wayne Township and in the centerline of County Road 180 (Fairmount Road);

Thence S.89°46'07"E. along the centerline of County Road 180 and the North line of the Northwest Quarter of Section 15, a distance of 1,322.97 feet to a Mag Nail set;

Thence S.00°51'18"W. along the centerline of Township Road 283 and the East line of the West Half of the Northwest Quarter of Section 15, a distance of 1,324.69 feet to a Mag Nail set, which is the PLACE OF BEGINNING for the tract of land herein described;

Thence continuing S.00°51'18"W. along the above described line, a distance of 664.69 feet to a Mag Nail set;

Thence N.89°42'56''W. a distance of 660.00 feet to an iron pin set, passing thru an iron pin set for reference at 20.00 feet in the West right-of-way line of Township Road 283;

Thence S.00°51'18"W. a distance of 660.00 feet to an iron pin set;

Thence N.89°42'56"W. along the South line of the Northwest Quarter of Section 15, a distance of 658.74 feet to a Wood Corner Post found;

Thence N.00°45'49"E. along the West line of the Northwest Quarter of Section 15, a distance of 1,324.06 feet to an iron pin set;

Thence S.89°44'32"E. a distance of 1,320.86 feet to the Mag Nail set, passing thru an iron pin set for reference at 1,300.86 feet in the West right-of-way line of Township Road 283, said Mag Nail was the true PLACE OF BEGINNING.

Containing in all 30.125 Acres of which 0.305 Acre is subject to easement for highway purposes. Thence S.89°46'07"E. along the centerline of County Road 180 and the North line of the Northwest Quarter of Section 15, a distance of 1,322.97 feet to a Mag Nail set;

Thence S.00°51'18"W. along the centerline of Township Road 283 and the East line of the West Half of the Northwest Quarter of Section 15, a distance of 1,989.38 feet to a Mag Nail set, which is the PLACE OF BEGINNING for the tract of land herein described:

Thence continuing S.00°51'18"W. along the above described line, a distance of 660.00 feet to a Mag Nail set;

Thence N.89°42'56"W. along the South line of the Northwest Quarter of Section 15, a distance of 660.00 feet to an iron pin set, passing thru an iron pin set for reference at 20.00 feet in the West right-of-way line of Township Road 283;


Thence N.00°51'18"E. a distance of 660.00 feet to an iron pin set;
