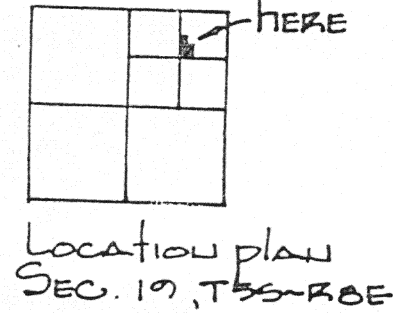
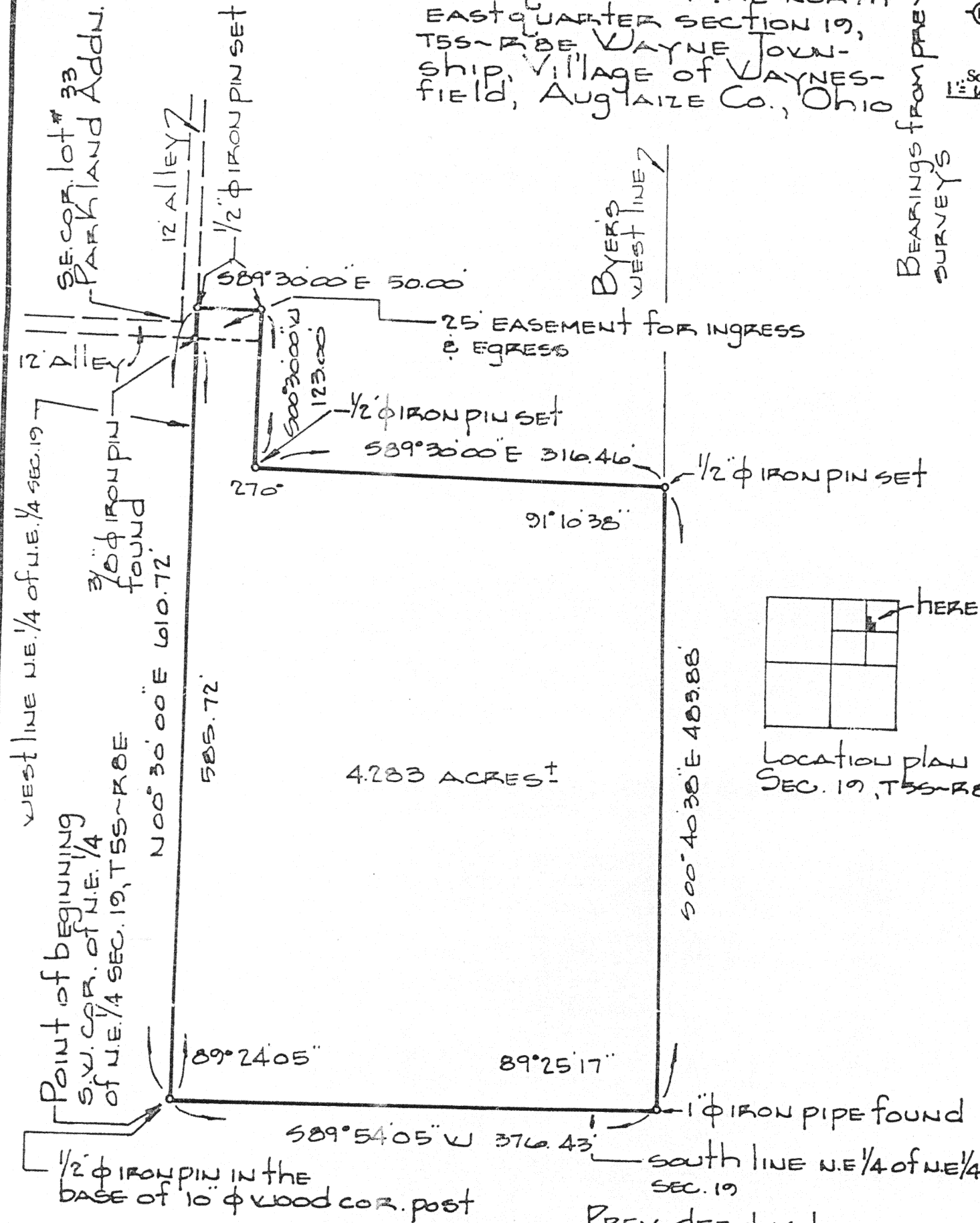

BEARINGS from PREVIOUS SURVEYS



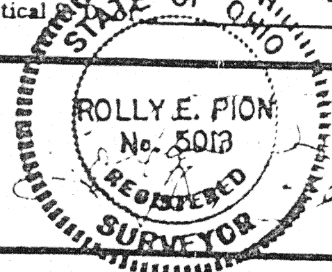
Location plan SEC. 19, T55~R8E

DESCRIPTION

Being a parcel of land situated in the northeast quarter of the northeast quarter of section 19, T5S - R8E, Wayne Township, Village of Waynesfield, Auglaize County, Ohio, and more fully described as follows:

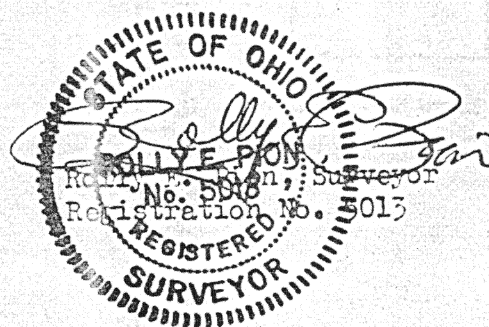

Beginning at a point (said point being an iron pin in the base of a 10" dia. wood corner post marking the southwest corner of the northeast quarter of the northeast quarter of section 19, T5S - R8E); thence N00°30'00"E along the west line of the northeast quarter of the northeast quarter of section 19 for a distance of 610.72' to an iron pin set; thence S89°30'00"E with an interior angle of 90°00' for a distance of 50.00' to an iron pin set; thence S00°30'00"W with an interior angle of 90°00' for a distance of 123.00' to an iron pin set; thence S89°30'00"E with an interior angle of 270°00' for a distance of 316.46' to an iron pin set; thence S00°40'38"E with an interior angle of 91°10'38" for a distance of 483.88' to an iron pipe found on the south line of the N.E. quarter of the N.E. quarter of section 19; thence S89°54'05"W with an interior angle of 89°25'17" along the south line of the northeast quarter of the northeast quarter of section 19 for a distance of 376.43' to the Point of Beginning.

Said parcel of land contains 4.283 acres, more or less, and is subject to all legal highways and easements of records.

An easement for egress and ingress is to be established across the north. 25.00' of the above described parcel for the abutting land on the north and east sides of said parcel.
