## SURVEYOR'S DESCRIPTION FOR 5.01 ACRE PARCEL

The following described parcel of land is situated in the Southwest Quarter of Section 9, Wayne Township, Town-5-South, Range-8-East, Auglaize County, Ohio, and is more particularly described as follows:

Commencing at a Monument Box located at the Southwest Corner of the Southwest Quarter of said Section 9, Wayne Township, also being at the intersection of Fairmount Road (County Road #180) and Moyer Road (Township Road #271);

Thence with a bearing of S. 89°-44'-02" E. along the South Line of the Southwest Quarter of said Section 9, Wayne Township, and the centerline of Fairmount Road, for a distance of 999.00 feet to a Mag Nail/Shiner (set) and the PLACE OF BEGINNING;

Thence with a bearing of N. 00°-54'-41" E. for a distance of 519.64 feet to an Iron Pin (set), and passing thru an Iron Pin (set) for reference at a distance of 25.00 feet;

Thence with a bearing of S. 89°-44'-02" E. for a distance of 420.00 feet to an Iron Pin (set);

Thence with a bearing of 5.00°-54'-41" W. for a distance of 519.64 feet to a Mag Nail/Shiner (set), and passing thru an Iron Pin (set) for reference at a distance of 494.64 feet;

Thence with a bearing of N. 89°-44'-02" W. along the South Line of the Southwest Quarter of said Section 9, Wayne Township, and the centerline of Fairmount Road, for a distance of 420.00 feet to a Mag Nail/Shiner (set) and the PLACE OF BEGINNING.

Containing in all 5.01 Acres, of which, 0.24 Acre being previously dedicated for highway purposes. The above described parcel of land is also subject to all other legal easements, reservations, or restrictions, if any, upon said premises.
