## LEGAL DESCRIPTION

Being a part of Out Lot 59 to the Village of New Knoxville, Auglaize County as evidenced by Official Record Volume 475, Page 1262 and more particularly described as follows:

Commencing for reference at an iron spike (found) at the southeast corner of Out Lot 60 to the Village of New Knoxville, said spike also being on the centerline of State Route 219; thence, S 89 degrees 07' 11" W along the south line of the southwest quarter of Section 20, and the centerline of State Route 219, (passing through an iron spike found at a distance of 215.76 feet) for a total distance of 330.76 feet to an iron spike (found) at the southeast corner of Out Lot 59, said spike being the **POINT OF BEGINNING** for the parcel herein described:

thence, continuing along the aforesaid south line and centerline and the south line of Out Lot 59, S 89 degrees 07' 11" W, for a distance of 6.00 feet to a mag-nail (set);

thence, N 00 degrees 06' 09" W (passing through a 5/8" re-rod w/cap set on the north right-of-way line of SR 219 at a distance of 30.00 feet) for a total distance of 238.00 feet to a 5/8" re-rod w/cap (set);

thence, N 89 degrees 07' 11" E for a distance of 6.00 feet to a 5/8" re-rod w/cap (found) on the east line of Out Lot 59;

thence, S 00 degrees 06' 09" E along the east line of Out Lot 59 (passing through a 5/8" re-rod w/cap found on the north right-of-way line of SR 219 at a distance of 208.00 feet) for a total distance of 238.00 feet to the **POINT OF BEGINNING**, containing therein 1,428 square feet or 0.033 acres, of which 180 square feet is road right-of-way. Subject to all easements and right-of-way or record at the time of the recording of this instrument. Prepared by James M.
