

## PERRY DESCRIPTION 1.422 ACRE

Thence N.89°28'19"W. along the North line of the Southwest Quarter of Section 21 and the centerline of County Road 166, a distance of 900.00 feet to a Mag Nail set;

Thence S.01°29'03"W. along the common property line between Gregory and Teresa Perry, Deed O.R. 92, Page 909 and the Charles and Joyce Anthony, Deed O.R. 112, Page 873, a distance of 300.08 feet to an iron pin set, which is the PLACE OF BEGINNING for the tract of land herein described;

Thence continuing S.01°29'03"W. a distance of 320.47 feet to an iron pin set; Thence N.83°17'46"W. along the common property line of Charles and Joyce Anthony Deed O.R. 112, Page 873 and Joann F. Baranowski, Trustee, Deed Volume 260, Page 756, a distance of 200.80 feet to an iron pin set;

Thence N.01°29'03"E. a distance of 298.84 feet to an iron pin set;


Thence S.89°28'36"E, a distance of 200.00 feet to the iron pin which was the true PLACE OF BEGINNING.

Thence S.01°05'17"W. along the common property line between Donald and Dixie Zink, Deed O.R. 306, Page 828 and Eric W. Schuler, Deed O.R. 437, Page 147, a distance of 300.10 feet to an iron pin set, which is the PLACE OF BEGINNING for the tract of land herein described;

Thence S.89°28'36"E. a distance of 226.38 feet to an iron pin set, passing thru a wooden post at 3.29 feet;

Thence S.01°29'03"W. a distance of 298.84 feet to an iron pin set;

Thence N.83°17'46"W. along the common property line of Charles and Joyce Anthony Deed O.R. 112, Page 873 and Joann F. Baranowski, Trustee, Deed Volume 260, Page 756, a distance of 226.73 feet to an iron pin set;


