


LEGAL DESCRIPTION

Being a part of the southwest quarter of Section 18, Town-6-South, Range-4-East, St. Marys Township, Auglaize County, Ohio as evidenced by Official Record Volume 309, Page 138, and more particularly described as follows:

Commencing for reference at a monument box (found) at the southeast corner of the southwest quarter of Section 18, and the legal centerline of Schroeder Road; thence, N 01 degree 09' 41" E along the east line of the southwest quarter of Section 18 and the legal centerline of Schroeder Road, for a distance of 690.55 feet to a point (said point being referenced by a 5/8" re-rod w/cap found N 88 degrees 50' 19" W of and 25.00 feet from said point); thence, N 88 degrees 50' 19" W for a distance of 115.00 feet to a 5/8" re-rod w/cap (set), said re-rod being the **POINT OF BEGINNING** for the tract herein described:

thence, continuing N 88 degrees 50' 19" W for a distance of 100.00 feet to a 5/8" re-rod w/cap (found);

thence, N 01 degree 09' 41" E for a distance of 75.00 feet to a 5/8" re-rod w/cap (set);

thence, S 88 degrees 50' 19" E for a distance of 100.00 feet to a 5/8" re-rod w/cap (set);
