

NORTH DESCRIPTION 29,330 SQUARE FEET

The following described tract of land is Lot No. 25 and part of Fraction 2 in the Jim Gehrlich's 2nd Subdivision, being part Lots 2 & 3, Hammels Estate, of Section 30, Town 5 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio and is more particularly described as follows:

The PLACE OF BEGINNING is at an iron pipe found at the Northwest corner of Lot No. 25 of the Jim Gehrlich's 2nd Subdivision as recorded in Plat Book "B", page 106, in the Auglaize County Recorder's Office;

Thence N.89°44'11"E. along the North line of Lot No. 25, a distance of 148.61 feet to an iron pipe found;

Thence S.03°16'25"E. along the common property line between Lots No. 25 and 26, said Subdivision, a distance of 150.19 feet to a 2-inch diameter iron bar found;

Thence N.89°39'45"E. a distance of 18.00 feet to an iron pin set;

Thence S.00°59'02"E. a distance of 49.94 feet to an iron pin set;

Thence S.89°36'27"W. along the South line of Fraction 2, a distance of 132.07 feet to a Creosoted corner post found;

Thence N.01°42'35"W. along the West line of Fraction 2 and Lot No. 25, a distance of 200.31 feet to the iron pipe which was the true PLACE OF BEGINNING.

Containing in all 29,330 Square Feet and is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume O.R. 238, page 438. This survey and plat is recorded in Survey Book "O", page 307 in the Auglaize County Engineer's Office. The PLACE OF BEGINNING is at an iron pipe found at the Southeast corner of Lot No. 13 of the Kelley's Oakwood Subdivision as recorded in Plat Book "B", page 9, in the Auglaize County Recorder's Office;

Thence S.89°24'00"W. along the South line of Lot No. 13, a distance of 150.14 feet to an iron pipe found;

Thence N.00°18'19"W. along the common property line between Lots No. 13 and 14, in said Subdivision, a distance of 134.03 feet to an iron pin found;

Thence S.89°36'27"W. a distance of 18.18 feet to an iron pin set;

Thence N.00°59'02"E. a distance of 49.94 feet to an iron pin set;

Thence N.89°39'45"E. along the North line of Fraction 2, a distance of 18.00 feet to a 2-inch diameter iron bar found;

Thence N.89°28'24"E. along the North line of Fraction 2, a distance of 150.12 feet to an iron pin set over an original iron pipe found;

Thence S.00°59'02"E. along the East line of Fraction 2 of the Jim Gehrlich's 2nd Subdivision, a distance of 50.20 feet to an iron pipe found;

Thence S.00°18'34"E. along the East line of Lot No. 13 of the Kelley's Oakwood Subdivision, a distance of 133.55 feet to the iron pipe which was the true PLACE OF BEGINNING.
