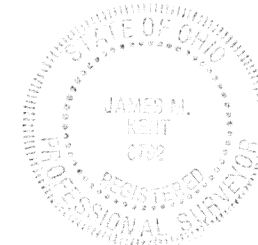
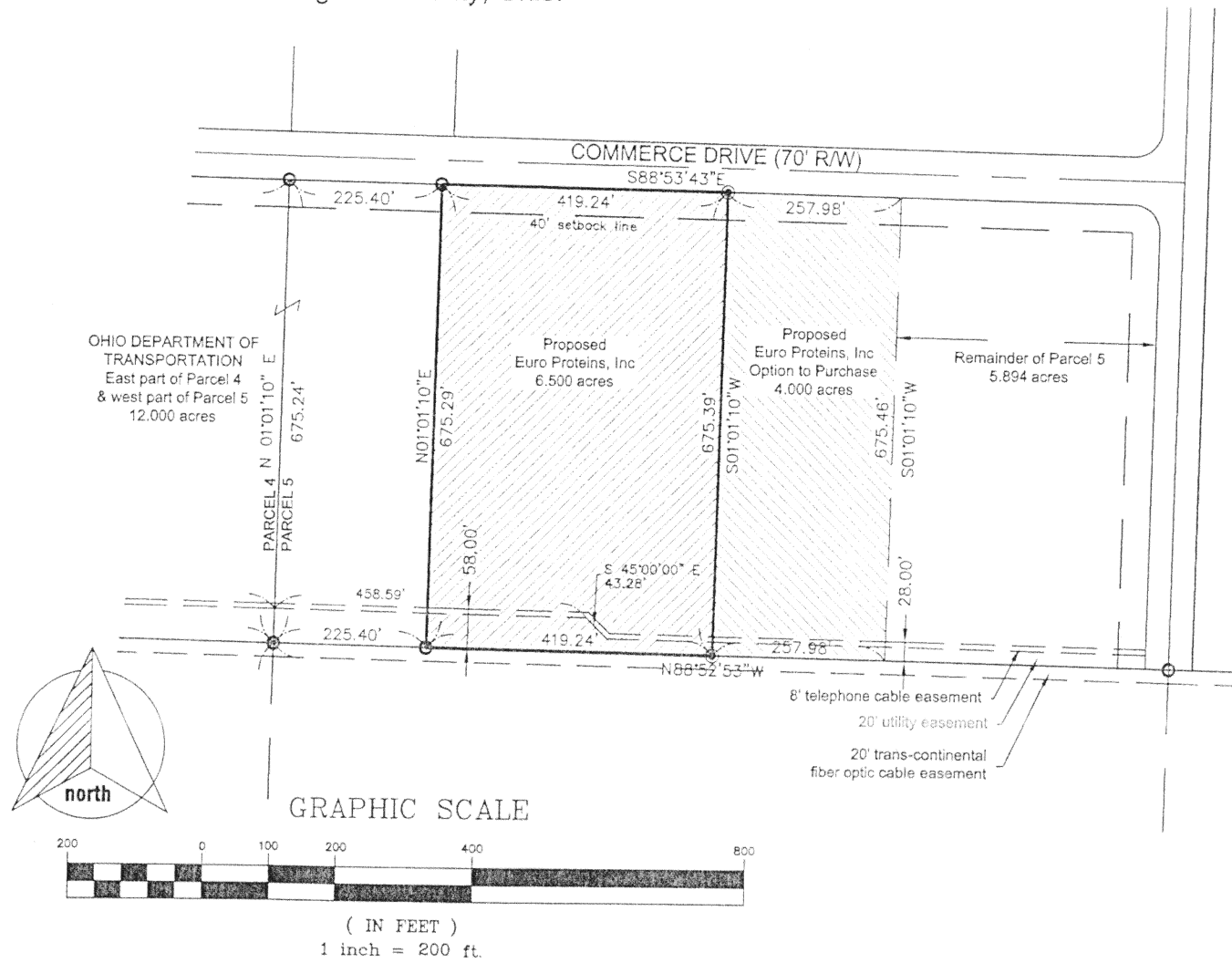

Auglaize County, Ohio.

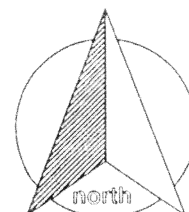

LEGAL DESCRIPTION

Situate in the middle part of Parcel 5 of the West Central Ohio Industrial Park to the City of Wapakoneta, and more particularly described as follows:

Commencing for reference at a 5/8" re-rod w/cap (found) at the northwest corner of said Parcel 5; thence, S 88 degrees 53' 43" E along the north line of Parcel 5 and the south right-of-way line of Commerce Drive, for a distance of 225.40 feet to a 5/8" re-rod w/cap (found), said re-rod being the **POINT OF BEGINNING** for the tract herein described;

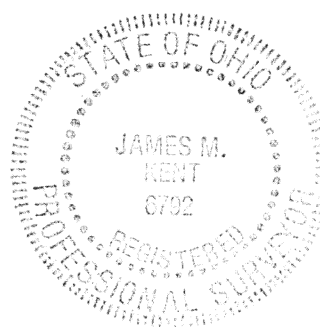
thence, continuing along the aforesaid north line and right-of-way line, S 88 degrees 53' 43" E, for a distance of 419.24 feet to a 5/8" re-rod w/cap (set);

thence, S 01 degree 01' 10" W for a distance of 675.39 feet to a 5/8" re-rod w/cap (set) on the south line of Parcel 5;


thence, N 88 degrees 52' 53" W along the aforesaid south line of Parcel 5, for a distance of 419.24 feet to a 5/8" re-rod w/cap (found);

thence, N 01 degree 01' 10" E for a distance of 675.29 feet to the **POINT OF BEGINNING**, containing therein 6.500 acres. Subject to easements and right-of-way of record. Prepared by James M. 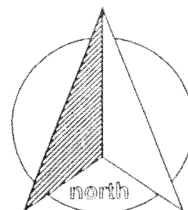

Option to Purchase

Situate in the middle part of Parcel 5 of the West Central Ohio Industrial Park to the City of Wapakoneta, and more particularly described as follows:


Commencing for reference at a 5/8" re-rod w/cap (found) at the northwest corner of said Parcel 5; thence, S 88 degrees 53' 43" E along the north line of Parcel 5 and the south right-of-way line of Commerce Drive, for a distance of 644.64 feet to a 5/8" re-rod w/cap (set), said re-rod being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing along the aforesaid north line and right-of-way line, S 88 degrees 53' 43" E, for a distance of 257.98 feet to a point;

thence, S 01 degree 01' 10" W for a distance of 675.46 feet to a point on the south line of Parcel 5;


thence, N 88 degrees 52' 53" W along the aforesaid south line of Parcel 5, for a distance of 257.98 feet to a 5/8" re-rod w/cap (set);
