Being a part of Lots 54, 55, 56 & 57 of the South Addition to St. Marys, Auglaize County, Ohio as evidenced by OR Volume 448, Page 96 and more particularly described as follows:

Commencing for reference at a 5/8" re-rod w/cap (found) at the intersection of the westerly right-of-way line of Front Street and the centerline of a vacated alley (Ordinance #1924) said alley being immediately south of lot 56 and 57 of said South Addition; thence, N 26 degrees 25' 00" W along the westerly right-of-way line of Front Street for a distance of 57.04 feet to a 1" iron pipe (found); thence, S 63 degrees 29' 47" W for a distance of 54.03 feet to a 5/8" re-rod w/cap (set), said re-rod being the POINT OF BEGINNING for the tract herein described;

thence, continuing S 63 degrees 29' 47" W (passing through a 5/8" re-rod w/cap found at a distance of 6.13 feet and a 5/8" re-rod w/cap found on the easterly easement line of Main Street at a distance of 95.00 feet) for a total distance of 111.13 feet to the west line of lot 57;

thence, N 26 degrees 25' 00" W along the westerly line of lot 57 and 54, for a distance of 45.00 feet to a point;

thence, N 63 degrees 29' 47" E (passing through the easterly easement line of Main Street at a distance of 12.28 feet and a 5/8" re-rod w/cap found at a distance of 111.17 feet to a 5/8" re-rod w/cap (set);



Commencing for reference at a 5/8" re-rod w/cap (found) at the intersection of the westerly right-of-way line of Front Street and the centerline of a vacated alley (Ordinance #1924) said alley being immediately south of lot 56 and 57 of said South Addition; thence, N 26 degrees 25' 00" W along the westerly right-of-way line of Front Street for a distance of 57.04 feet to a 1" iron pipe (found), said pipe being the **POINT OF BEGINNING** for the tract herein described;

thence, S 63 degrees 29' 47" W for a distance of 54.03 feet to a 5/8" re-rod w/cap (set);

thence, N 26 degrees 22' 02" W for a distance of 45.00 feet to a 5/8" re-rod w/cap (set);

thence, N 63 degrees 29' 47" E (passing through a 5/8" re-rod w/cap found at a distance of 5.00 feet and a 5/8" re-rod w/cap found at a distance of 6.17 feet) for a total distance of 54.00 feet to the westerly right-of-way line of Front Street;

thence, S 26 degrees 25' 00" E along the aforesaid westerly right-of-way line of Front Street, for a distance of 45.00 feet to the **POINT OF BEGINNING**, containing therein 2,431 square feet overall.
