



WILLIAMS DESCRIPTION PART OF OUTLOT NO. 90

Being a part of Outlot No. 90, located in Section 33, Town 5 South, Range 6 East, Duchouquet Township, in the City of Wapakoneta, Auglaize County, Ohio and is more particularly described as follows:

The PLACE OF BEGINNING is at an iron pin found at the Southeast corner of Outlot No. 90 in the City of Wapakoneta;

Thence N.89°58'24"W. along the North right-of-way line of East Benton Street, a distance of 50.04 feet to an iron pin found;

Thence N.02°41'26"W. along the East line of the R.C. Hemmert property as described in Deed Volume DV 145, page 422, a distance of 150.11 feet to an iron pipe found;

Thence N.89°59'40"E. a distance of 50.00 feet to an iron pin found;

Thence S.02°42'20"E. along the West line of the J. Kirchhofer property as described in Deed Volume OR 488, page 610 and along the East line of Outlot No. 90, a distance of 150.14 feet to the iron pin at the Southeast corner of Outlot No. 90, which was the true PLACE OF BEGINNING.

Containing in all 7,501 square feet and being subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. This description is based on an actual field survey performed by John W.
