DESCRIPTION

Being a part of Outlot 109 to the City of Wapakoneta, Auglaize County, Ohio as evidenced by Official Record Volume 496, Page 2070 & 2072, and more particularly described as follows:

Commencing for reference at a railroad spike (found) at the intersection of the centerline of Wheeler Lane and the easterly projection of the south line of Outlot 109; thence, N 89 degrees 35' 09" W for a distance of 9.24 feet to the southeast corner of Outlot 109; thence, N 01 degree 21' 00" E, along the east line of Outlot 109, for a distance of 175.00 feet to a mag-nail (set), said nail being the **POINT OF BEGINNING** for the tract herein described;

thence, N 89 degrees 35' 49" W (passing through a 5/8" re-rod w/cap set on the west right-of-way line of Wheeler Lane at a distance of 15.76 feet) for a total distance of 199.90 feet to a 5/8" re-rod w/cap (set);

thence, N 01 degree 21' 15" E for a distance of 25.00 feet to a concrete monument (found);

thence, S 89 degrees 35' 49" E (passing through a 5/8" re-rod w/cap set on the west right-of-way line of Wheeler Lane at a distance of 184.14 feet) for a total distance of 199.90 feet to a mag-nail (set) on the east line of Outlot 109;

thence, S 01 degree 21' 00" W along the aforesaid east line, for a distance of 25.00 feet to the **POINT OF BEGINNING**, containing therein 4,997 square feet, or 0.115 acres, of which 0.009 acres is road right-of-way. Commencing for reference at a railroad spike (found) at the intersection of the centerline of Wheeler Lane and the easterly projection of the south line of Outlot 109; thence, N 89 degrees 35' 09" W for a distance of 9.24 feet to the southeast corner of Outlot 109, said southeast corner being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing along the south line of Outlot 109, N 89 degrees 35' 09" W (passing through a concrete monument found on the west right-of-way line of Wheeler Lane at a distance of 15.76 feet) for a total distance of 199.91 feet to a concrete monument (found);

thence, N 01 degree 21' 15" E for a distance of 174.96 feet to a 5/8" re-rod w/cap (set);

thence, S 89 degrees 35' 49" E (passing through a 5/8" re-rod w/cap set on the west right-of-way line of Wheeler Lane at a distance of 184.14 feet) for a total distance of 199.90 feet to a mag-nail (set) on the east line of Outlot 109;

thence, S 01 degree 21' 00" W along the aforesaid east line, for a distance of 175.00 feet to the **POINT OF BEGINNING**, containing therein 0.771 acres, of which 0.082 acres is road right-of-way.
