Being a parcel of land situated in Noble Township, Anglaize County, Ohio, in the northwest quarter of Section 16, Township 5 South, Range 4 East. Being more particularly described as follows:

Beginning at an iron bar in a monument box at the southwest corner of the northwest quarter of said Section 16 -

Thence, North 89°43'21" East, along the south line of the northwest quarter of said Section 16 and the centerline of Arnold Road, a distance of 380.21 feet to a spindle -

Thence, North, a distance of 725.06 feet to a 5/8 inch iron bar -

Thence, West, a distance of 380.21 feet to a spindle -

Thence, South, along the west line of the northwest quarter of said Section 16 and the centerline of State Route 116, a distance of 150.00 feet to a P.K. nail -

Thence, East, a distance of 312.21 feet to a 5/8 inch iron bar -

Thence, South, a distance of 196.03 feet to a 5/8 inch iron bar -

Thence, West, a distance of 312.21 feet to a P.K. nail -

Thence, south, along the west line of the northwest quarter of said Section 16 and the centerline of State Route 116, a distance of 380.87 feet to the place of beginning.
