Being a part of the southwest quarter of Section 18, Town-6-South, Range-4-East, St. Marys Township, Auglaize County, Ohio and more particularly described as follows:

Commencing for reference at a monument box (found) at the southeast corner of the southwest quarter of Section 18, and the legal centerline of Schroeder Road; thence, N 01 degree 09' 41" E along the east line of the southwest quarter of Section 18 and the legal centerline of Schroeder Road, for a distance of 615.55 feet to a point; thence, N 88 degrees 50' 19" W (passing through a 5/8" re-rod w/cap found on the west right-of-way line of Schroeder Road at a distance of 25.00 feet) for a total distance of 215.00 feet to a 5/8" re-rod w/cap (found), said 5/8" re-rod being the **POINT OF BEGINNING** for the parcel herein described;

Thence, continuing N 88 degrees 50' 19" W (passing through a 5/8" re-rod w/cap set for reference at a distance of 36.55 feet) for a total distance of 40.55 feet to the water's edge of a channel;

Thence, N 06 degrees 01' 27" E along the water's edge of said channel, for a distance of 76.74 feet to a chiseled "X" (set) in the west top of a steel "I"-Beam;
