


The PLACE OF BEGINNING is at an iron pin set at the Northeast corner of Lot No. 26 in the Georgetown Estates Subdivision, Phase 2;

Thence S.01°54'52"W. along the East line of Lot No. 26, a distance of 78.08 feet to an iron pin set;

Thence N.88°05'08"W. along the projected common wall line of a duplex residence, a distance of 122.80 feet to an iron pin set;

Thence N.01°57'16"W. along the West line of Lot No. 26, a distance of 61.13 feet to an iron pin found;

Thence Northeasterly, along a curve to the right having the following curve data: Radius 15 feet, Arc length 23.28 feet, the chord of which bears N.46°24'47"E. a distance of 21.01 feet to an iron pin found;

Thence S.89°07'43"E. along the North line of Lot No. 26, a distance of 108.04 feet to the iron pin at the Northeast corner of Lot No. 26, which was the true PLACE OF BEGINNING.

Thence S.01°54'52"W. along the East line of Lot No. 26, a distance of 45.50 feet to an iron pin found;


