

PAUL H. MEYER ESTATE SURVEY 22.703 ACRE

The following described tract of land is part of the Southwest Quarter of Section 35, Town 7 South, Range 4 East, Jackson Township, Auglaize County, Ohio and is more particularly described as follows:

The PLACE OF BEGINNING is at a Monument Box found at the Northwest corner of the Southwest Quarter of Section 35, Jackson Township;

Thence S.01°26'33"W. along the East line of the Southwest Quarter of Section 35, a distance of 758.20 feet to a Mag Nail set, passing thru a Mag Nail set for reference at 30.00 feet in the South right-of-way line of East First Street (State Route 362);

Thence N.89°48'22"W. along the North line of the S. & T. Wacker property as described in Deed Volume OR 134, page 70-79, a distance of 1,309.09 feet to an iron pin found from a previous survey;

Thence N.01°21'07"E. along the East line of the Dannon Company property as described in Deed Volume OR 175, page 815, a distance of 752.35 feet to an iron pin set in the South right-of-way of East First Street (State Route 362);

Thence N.89°56'21"E. along the North line of the Southwest Quarter of Section 35, a distance of 1,310.42 feet to the Monument Box which was the true PLACE OF BEGINNING.

Containing in all 22.703 Acres subject to easement for highway purposes. The above-described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume 156, page 356. Basis of bearing is from a previous boundary survey of 50.582 Acres by Allen & associates dated June, 1984. This description is based on an actual field survey, performed by me, John W. Jauert in July 2004.
